ELIZABETH HAGIN

Born 1809 in Clarke County, Georgia, married 1823 Clarke County, Georgia to Archibald Holland. Archibald Holland was born in Virginia in 1800 and came to Georgia when he was about 12 years of age. He took his bride to Paulding County, where she died December 22, 1840. She is buried in the Holland Family Cemetery, located in Land Lot 1043 of the 18th District, Third Section, Paulding County, on the northside of Marietta-Van Wert Road, near Dallas, Georgia.

Elizabeth's brother, Edward Hagin, left Clarke County about the same time as his sister, untimately following her to Paulding County, where he also settled.

Elizabeth was a daughter of -

EDWARD HAGIN

Born 1782 in Wilkes County, Georgia, died after 1850 Coosa County Alabama. He was listed on the 1850 Census of that county, and I was unable to locate any estate records of him in Coosa County. He was referred to in the records as "Edward Hagin, Jr.". He married January 8, 1807 in Richmond County, Georgia, to Sally Youngblood, the daughter of Peter and Susannah Youngblood of South Carolina. Sally died before 1812 in Clarke County, Georgia.

He married second Heardy Porch October 29, 1812 in Clarke County, Georgia, who was listed on the 1830 DeKalb County Census, age between 30 and 40 years.

The family moved to Coosa County, Alabama sometime after 1845.

Children of Edward Hagin and his first wife, Sally Youngblood:

I. Edward Hagin, born August 26, 1807 Clarke County, Georgia, died July 4, 1890 Paulding County, Georgia. Buried High Shoals Cemetery, Paulding County, with his wife. Married Parthenia Scroggins January 13, 1828. The Will of Edward is recorded in Book A (1885–1937), Page 33, Paulding County, Georgia, and is dated May 24, 1890. He names his wife, Margaret and children: Henry N. Hagin, Mary J. Spinks, James J. Hagin, L. C. Forsyth,

Benjamin F. Hagin, Dicy C. Hays, and Thomas C. Hagin. Wife's nephew, William Thompson, also mentioned.

II. Elizabeth Hagin, born 1809 Clarke County, Georgia, died December 22, 1840 Paulding County, married 1823 Clarke County, Archibald Holland, who drew in the 1821 Georgia Land Lottery, a resident of Greene County, Lot 82, District 14, Henry County. This is the same land which was DeKalb County in 1830, now Fulton County, in what is now the Luckie Street area.

EDWARD HAGIN

REVOLUTIONARY WAR SOLDIER

Born about 1755 in South Carolina. Signed a petition along with the other residents of Wrightsborough, Georgia, August 30, 1774, as follows:

"Town of Wrightsborough

We, the Inhabitants of the Town of Wrightsborough and places adjacent, understanding that fourteen persons have drawn up several resolutions respecting the dispute between Great Britain and the Town of Boston, concerning the destroying of a quantity of tea, the property of the East India Company, and have published them each the Act of the Province, and which we look upon as a great imposition, having no knowledge of them 'till they were passed; Therefore, we do, in this public manner, deny passing any concerning them, and disapprove of them altogether, such proceeding as a few acting for the whole without the knowledge, we apprehend being contrary to the rights and privileges of every British subject." 30 August 1774"

This day His Honour, the Governor, signed the following grants in Council,

viz: Washington County - Edward Hagin - 287 1/2 acres (two)."

Wilkes County, Georgia Deed

2 February 1786. Edward Hagen and wife, Elizabeth, deed to Charles Carroll 200 acres of land on Little River at the mouth of Kettle Creek.

Edward Hagin was Captain of the 9th Company, Washington County, Georgia Militia in 1787. He was Coroner in Washington County in 1790 and 1792; and was first found in Clarke County, Georgia in 1802.

Clarke County, Georgia Deed

Book A, Page 302, September 15, 1802, Roger Cagle of Clarke County to Edward Hagins of Clarke County, for \$400.00 124 acres located on Barbers Creek, land originally granted to Marbury. Witness: Edward Moore.

From Georgia's Roster of the Revolution by Lucian Lamar Knight, Edward Hagin was certified a List of the Georgia Troops. Elijah Clarke certified him as a Refugee Soldier April 7, 1784 and he received 287 1/2 acres of land in Washington County as bounty lands.

Edward Hagin made a Will in Clarke County dated 1805 which names "all my children". However, various Returns were made on the Estate, and among the legatees named were: Edward Hagin, Jr. and James Hagin. Will Book A, (1802-22), Page 377-8, Mixed Records and Returns, Estate of Edward Hagin. Wife, Hannah, named in Will.

Children:

I. Daniel Hagin, born about 1788, married June 1, 1813 Clarke County, Georgia, Elizabeth Hewsome. In 1827 Land Lottery, he drew as a Soldier in Walton County. From 1825-30 he was a Lt. in Appling County; listed on 1811-21 Clarke County Tax Digests, and was last found on 1830 Coweta Co. Georgia Census.

- II. James Hagin, listed on the 1813 Clarke County Tax Digest. The Orphans of James Hagin drew as residents of Clarke County in 1820 land in Early County. He died 1814 Clarke County, Georgia when Bond of Jesse Roberts and Thomas Moore was made May 2, 1814, Estate of James Hagin, Page 35, Clarke County Administrators Bonds (1811–39). It is believed that James Hagin Gayle of Virginia.
- III. Edward Hagin, Jr., born 1782 Wilkes County, Georgia, died after 1850 Coosa County, Alabama. Married first January 8, 1807 Sally Youngblood in Richmond County, and second Heardy Porch October 29, 1812 Clarke County.

KNOW ALL MEN BY THESE PRESENTS that we, Ann and Edward Hagan, as Principals, and George Dolly, as Security, all of the county aforesaid, are held firmly bound unto William Phillips, Register of Probate for said county, their successors and assigns, as the principals, in the sum of \$150.00, which payment will and truly be made and done. We, and each of us, jointly and severally, do bind ourselves, our heirs, executors, administrators to do firmly by these presents sealed with our seals and dated this 15 day of September 1798.

THE CONDITION of the above obligation is such that if the above bound, Ann and Edward Hagans, administrator or administrators of the goods and credits of James Hagans, deceased, do make a true and perfect inventory of all and singular the goods and chattels and credits of the said deceased, shall have or shall come to the hands, possession or knowledge of the said Ann and Edward Hagins or unto the hand or hands or possession of any other person or persons for them and the same as made to do exhibit unto the said court of Greene when they shall be thereunto requested....

HUSBAND - Edward Hagin

Revolutionary War Soldier; LWT dated 1805 in Clarke County, Georgia.

30 August 1774, Edward Hagin signed a petition against Great Britain, while a resident of Wrightsboro, Georgia. In 1784 he was granted 287 1/2 acres in Washington County for his Revolutionary War Service.

Daniel Hagin was listed on the 1811-1821 Clarke County Tax Digests; drew in the 1827 Georgia Land Lottery as a Soldier in Walton County. From 1825-1830 he was a Lieutenant in Appling County; and was last found on the 1830 Coweta County Census.

James Hagin was listed on the 1813 Clarke County Tax Digest; in 1820 the orphans of James Hagin drew as residents of Clarke County in the lottery, land in Early County. He died 1814 in Clarke County when the bond of Jesse Roberts and Thomas Moore was made 2 May 1814, Estate of James Hagin, page 35, Clarke County Administrators' Bonds (1811-1839).
