I don't have any info. on this one, however, I will publish it as a query in my next Holland Newsletter.

Jeannette: I think I remember that you have HOLLANDs from GA. Mine were from SC to MS. Today, I was looking over some pages that some one sent me from the Webster Co MS Heritage Book and I happened to notice that there was as item on a MIDDLETON Family, who was living in Choctaw Co MS where my Rev. Soldier Charles HOLLAND finally finally settled. Charles had brothers Jacob and

Thomas who were also Rev. soldiers. Anyway, I became curious as the item on MIDDLETON said, "When the old Revolutionary War Soldier Holland MIDDLETON made his will in Hancock Co GA in 1795 he named his wife Mary (PARKS), five sons and two daughters. These five sons, Parks, Zachariah, John, Robert and Benjamin- remained in GA about twenty years and then moved with their families to Alabama, mostly in the Tuscaloosa area, where they lived about 15 yrs before they began moving into MS. (Hollands oldest son, Holland Jr. had also fought in the Revolution with his father in the Georgia Troops.)

These MIDDLETONS made the same moves as my HOLLANDS except they came from GA and mine came from MD to SC to MS. My question is, have you run into any of these MIDDLETONS in your HOLLAND GA line and could they be related way back somewhere or is this all a coinsidence? Do you have any thoughts on this? Pat Hoffman

I have tried (unsuccessfully) to locate my HOLLAND ancestors for the past six years. I've seen your name on the title page of more reference books than I can count at the Georgia Room at the Cobb Co. library, and was delighted to find your e-mail address on the Holland research page.

My HOLLANDS (that I know about) were HENRY HOLLAND and his wife, NANCY IDA NESBITT, daughter of JOHN BOYD NESBITT and MARGARET CAROLINE MOSS.

Most of this family, and the two connected families above, can be found at the Bethesa Baptist Church cemetery in Gordon County. Henry and Ida Holland are buried alongside M. D. HOLLAND and his wife AMANDA; are either of their names familiar to you?

The only clues I've ever found as to M.D.'s full name are (a) a census report listing a Marion and Amanda Holland as twenty-somethings with two-year-old son Henry, and (b) a listing for MATHEW HOLLAND in "Citizens of Georgia 1840".

The markers at Bethesda cemetery give the birth years for Henry and M. D. Holland as 1868 and 1834, respectively.

My late grandmother used to say that her mother, Lou Emma Holland Chapman, a daughter of Henry and Ida's, was always going on about her ancestors. Nanny didn't know exactly why, and her mother had been deceased for some time as

well, so my living resources are nil. I would be very grateful for your reply.

We Drury Dobbins a clergyman residing in the county of Rutherford and John Padget residing in the same county hereby certify that we are well acquainted with William Holland who has subscribed and sworn to the above deed and that we believe him to be eighty-six years of age, that he is reputed and believed in the neighborhool where he resides to have been a soldier in the Revolution and that we concur in that opinion. **Drury Dobbins**

Sworn to and subscribed the day and year aforesaid in open court.

Interrogations presented by the court and answered by the applicant.

1. Where and in what year were you borne?

Answer: In the State of Pennsylvania about the year 1747.

2. Have you any record of your age, if so where is it?

Answer: No other than that made by myself upon the statement made to me by my father, which is in an old Bible now in my possession.

3. Where were you living when called into service; where have you lived since the Revolutionary War, and where do you live now?

Answer: I lived in the county of Mecklenberg in this state when called into service and until about 45 years since, when I removed into Rutherford county where I have constantly resided since and now reside.

4. How were you called into service; were you drafted; did you volunteer, or were you a substitute?

Answer: I was a volunteer in the service.

5. State the names of some of the regular officers who were with the troops where you served; which continental and militia regiment or you can recollect and the general circumstances of your service.

Answer: Colonel Martin whose Christian name I do not remember a regular officer was with us in our march upon the British at Rudy River in South Carolina; Genl Daniel Morgan of the regular army was in camp on the [ ] own whilst [ ] [ ] these under command of Colonel Davie and Genl Davidson and previous to this battle with Tarleton at Cowpens. Gen G??me was in camp for a time and Colonel Washington of the Dragoons, but from the great length of time since I cannot recall any fact or occurence which will show the command

6. Did you receive a discharge from the service and if so by whom was it given and what has become of it?

Answer: I received but one written discharge from the service which states

the length of service of three months and is copied into my declaration accompanying this.

This is from the Revolutionary War records of the Mecklenburg/Rutherford NC William Holland (b. abt 1747-1837) whose wife was Margaret Hall. Records were hard to read and my eyes are not good, but hopefully they will help you in your research of the Rutherford Hollands. More follows.

State of North Carolina Rutherford County

On this tenth day of September 1832 personally appeared before the Court of Probate of Rutherford County now William Holland a resident of Rutherford County in the state of North Carolina aged eighty-five years who being first duly sworn according to law took his oath su[ink blop] the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832. That he entered the service of the United States and in the following named officers and as known stated. That he resided in the county of Mecklenberg of both Carolinas, he volunteered his services and marched to Rudy River in South Carolina against Cunningham and Commander of the Tories in that Quarter that they fell in with them and commenced fight but after a few shot, the Tories retreated and were dispersed and the troops to which I belonged returned to Mecklenberg after a service of from thirty-five to forty days. The troops [ ] belonged [ commanded by Colonel Thomas Polk, then Captain of the Company and Thomas Harris of Mecklenberg County and [ ] [ ] of Guilford County Lieutenant and Robert Sevier of Mecklenberg was the [ ] of the company. The regular soldiers in this town, about three hundred in number, were commanded by Colonel Martin, then an attorney at law and afterwards the Governor of North Carolina. I do not remember his Christian name nor do I remember the date of the year. It was in the winter season and exceptionally cold and [ ] thence called [ ]. I was next called on to march against the Cherokee Indians and required to rendezvous at what was called the Quaker Meadows in Burke County where with about one hundred others from Mecklenberg County they [ ] and the Indians having fled at their approach they remained there only about three weeks when they were ordered home to procure tomahawks and other arms and fixtures to march against the Indians in their own nation or country. Having gone home, this deponent remained there preparing for his march about three weeks, where he substituted his BROTHER MATHEW HOLLAND in his stead, who marched to the Indian nation [ ] then [ ] and fought them and returned but I am not able to state the length of time of his services nor the date of the year further than that when he with the others mentioned above went to the Ouaker Meadows. It was about the time of harvest, say July or thereabouts. The

detachment that marched to the Nation was commanded by Genl Griffith
Rutherford of Rowan County in North Carolina and by Colonel Drake[?] [
]company by Captain Harding. He remained at home until the British and
Tories after the evacuation of Charleston had marched up the county twice
being at Camden or the hanging Rock near that place, he was then called on
to volunteer in the troop commanded by Colonel Davie (afterwards the [
[ ] state) [ ] the Captain officers being for a time supplied by
myself. Colonel Davie stationed his forces on the Wasau[?] Creek
(maintained for [ ] a partisoan warfare with the British [ ] about two
months in summer when [ ] and took us from this encampment and marched
into Charlotte where they encamped. Gen W. G. Davidson had made a stand on
Rocky River about ten miles from Charlotte and Colonel Davie and his forces
were with him, [ ] occasion of frequent skirmishes with the foraging
parties occurred with Cornwallis the commander of the British was campted by
to learn this place and proceeded to Fairfield District South Carolina where
a subsistence could be more easily and safelyl procured - they were pursued
to the crossing of the Catawba River by Colonel Davie's forces. The British
remained at their camp near Minsboro about three months when they marched to
meet Gen Moore at Guilford Court House. They met at Cowan's ford of the
Catawba and their progress was opposed bly Genl Davidson who in attempting
to prevent their passage of the river was killed. Our army was dispersed
and they, the British, marched with little molestation to the Battle of
Guilford Court House. To this place they were pursued by many of the
Mecklenburgers but for [ ] I gave [ ] the pursuit as they passed
Mecklenburg [ ] expecting that they would be met and opposed by armies who
had been left [] [] then the people of Mecklenberg had been nevertheless [
]. I considered myself as in the service until the army had passed the
Gadkin River[?]. Whilst in Colonel Davie's camp at the Wacau above
mentioned prisoners were taken by the scouts and brought in frequently and I
was appointed commander of the guard who had charge of them. About this
time understanding that the British were at Cambden or Handling Rock near
there Colonel Davie [ ] for volunteers to go and attack them. I with
about one hundred thirty others [ ] on this service and after a march of
about forty miles meet them their cavalry increasing in a lane called
Woffords lane, attacked them on [ ] flank routed the cavalry. I took
their horses and returned after an [ ] from camp of about 24 horses.
Whilst I was in charge of the prisoners as mentioned above, being left in
camp with them, the new body of American forces commanded by Col Davie were
marched to the attack of the enemy at Rocky [ ] and at the hanging Rock.
This circumstance prevented my being present and partaking in those
engagements.
His services were of such constant [ ] in the county of his immediate [
] that they were principally rendered there, and at short intervals he was

being sent home, admetted to visit his family. His longest time of service was from just before harvest time to february making about 10 months, he considering that the whole time of his actual service amounts to about 18 months though at the time [ ] he considers that he was a soldier whenever called on for seven years. He has no documented military evidence of his service, having never taken a militia discharge except one for three months when his actual service had been about at least ten months. It is copied as follows.-

These are to certify that the bearing hereof Wm Holland, Ensign of Capt McKristy Company of the first Regiment of Draftsl raised in the district of Salisbury has finished three months agreeable to law and is hereby discharged. Given under my hand the 22nd day of 1780.

He herby relinquishes every claim whatever to a pension or an annuity except the present and he declares that his name is not on the pension roll of any Agency in any State or only on that of the Agency of the State of North Carolina.

Sworn to and subscribed the [ ] day and year aforesaid. And the said court do hereby certify this opinion that the above named applicant was a revolutionary soldier and served as he states.

More on the Rutherford NC William Holland (1747-1837).

I can not tell whether this page was torn from a bible/book or whether the

archives had the whole book. All we can see from the microfilm copy is a printed page from "The Psalms of DAVID in Metre" and on the reverse side (you can see the title page thru the paper) there is the handwritten record:

Marcus Holland was born in may the 2second in the year of our Lord - 1783 Matilda Holland was Born on December the twenty fifth in the year of our Lord 1784

Isaac Holland was [looks like the writer ran out of ink - can't read it, but Commissioner Church from the Pension Office? in 1929 transcribed the date as 3 June 1786]

Susanna Holland was born January the 11th A.D. 1788
