CHARLES RONALD MANSEL LEWIS, of Stradey Castle, co. Carmarthen, b. 23 June, 1880; *educ.* Eton; *m.* Nov. 1925, Lillian Georgina, widow of David Archibald James Chapman, Scots Guards, and younger dau. of the late Sir Thomas Courtenay Theydon Warner, C.B., 1st Bt., of Brettenham Park, Suffolk (see BURKE's *Peerage*), and has issue,

1. DAVID COURTENAY, b. 25 Oct. 1927.

Lineage.—THOMAS LEWIS, of Stradey, who s. to that estate 1808, under the will of Mrs. Mansel, dau. and eventual sole heir of Sir Edward Vaughan Mansel, 3rd Bt., of Trimsaran, and Stradey (see BURKE's *Extinct Baronetage*), and sister of Sir Edward Shewen Mansel, 4th and last Bt. (*d.s.p.* 6 Apr. 1798); *m.* Catherine, 2nd dau. of Daniel Lloyd, of Laques, co. Carmarthen, and had an only son,

Carmarthen, J.P. and D.L., High Sheriff 1833, B.A. Brasenose Coll., Oxford, Barrister-at-Law, M.P. for the Carmarthen Boroughs 1835-7, *m.* 9 June, 1836, Lætitia, youngest dau. of Benjamin Way, of Denham Place, Bucks (see *that family*), and *d.* 1872, having had issue,

HAMPTON-LEWIS (now DWYER-HAMPTON)
OF HENLLYS AND BODIOR

MARY GWENDOLEN, MRS. DWYER-HAMPTON, of Henlllys, Anglesey, *b.* 1 April, 1875; *m.* 3 Oct. 1914, Lieut.-Col. Bertie Cunynghame Dwyer, D.S.O., Leicestershire Regt., J.P. and D.L., High Sheriff of Anglesey 1929, eld. son of Capt. Robert Hoare Dwyer. They assumed by Royal Licence, 1915, the additional surname of HAMPTON.

Lineage.—WILLIAM HAMPTON, formed one of the garrison of Beaumaris Castle in 1460, and held there the rank of Deputy-Governor, as appears from a document bearing his name, giving orders to the inhabitants of the town to extinguish their fires at an appointed hour. He received a grant of Henlllys, Anglesey, anciently the seat of Gweirydd ap Rhys Goch, Chief of one of the Fifteen Tribes of North Wales. The eventual heiress of the Hamptons of Henlllys,

MARY HAMPTON, of Henlllys (only surviving child of Robert Hampton, High Sheriff of Anglesey 1732), *m.* 11 April, 1746, John Jones, of Trefollwyn, High Sheriff of Anglesey 1750, son of Hugh Jones of the same place, by Anne his wife, dau. of William Lloyd, of Llanisadwrn, and sister of Rev. Owen Lloyd, Rector of same place. She *d.* 22 Sept. 1759, having had by her husband (who *d.* May, 1760) a dau., Mary, *b.* 2 Nov. 1749, *m.* William Lloyd, of Rockville, co. Roscommon, and a son and successor,

JOHN HAMPTON JONES, of Henlllys, High Sheriff of Anglesey 1770, *b.* 24 Feb. 1746; *m.* 25 June, 1770, Emma, only dau. of the Rev. John Lewis, M.A., of Plas Llanfihangel, Rector of Llandegfan, by Elizabeth his wife, dau. of Thomas Roberts, of Bodior, and by her (who *d.* Nov. 1786) had with other issue,

JOHN HAMPTON HAMPTON-LEWIS, of Henlllys, D.L., High Sheriff 1813, Major Carnarvonshire Militia, *b.* 21 Nov. 1775, assumed by Royal Licence 1 June, 1830, the additional surname and arms of LEWIS; *m.* 19 Dec. 1796, Mary, dau. of Richard Chambers, of Whitbourn Court, and Cradley Hall, co. Hereford, widow of Thomas Harris Freeman, of Gains, same co., and had with other issue by her (who *d.* Jan. 1842),

JOHN LEWIS HAMPTON-LEWIS, of Henlllys and Bodior, J.P. and D.L., High Sheriff 1846, Major 5th Dragoon Guards, *b.* 18 Oct.

1798; *m.* 2 Sept. 1833, Elizabeth Frances, only child and heiress of Thomas l'Anson, of Prior House, Richmond, and *d.* 1871, having by her (who *d.* 1878) had issue,

1. THOMAS LEWIS HAMPTON, of Henlllys and Bodior.

2. John Vivian Hampton, *b.* 18 June, 1835; *m.* 2 June, 1868, Lady Laura Elizabeth Phipps (Oakdale, The Holmwood, Dorking), dau. of the 2nd Marquess of Normanby (see BURKE's *Peerage*), and *d.* 1890, leaving issue,

THOMAS LEWIS HAMPTON-LEWIS, of Henlllys and Bodior, Anglesey, J.P. and D.L., High Sheriff, 1869, Col. commanding Royal Anglesey Engineer Militia 1878 to 1891, and since 1891 Hon. Col. of that Corps, late of H.M. Hon. Corps of Gentlemen-at-Arms, and formerly Capt. 5th Dragoon Guards; *educ.* Sandhurst, entered the Army 1852, served in the Crimean war, 1854 to 1856, was at Balaklava, Inkerman, Tchernaya, and Sebastopol (medal with three clasps, Turkish war medal, and 5th Class of the Medjidie), *b.* 9 Aug. 1834; *m.* 20 Feb. 1872, Lettice Martha (now of Bodior, Anglesey), 2nd dau. of Henry Pritchard, of Trecawen, Anglesey, J.P. and D.L., and *d.* 10 March, 1912, having had issue,

1. John Arthur, *b.* 26 March, 1874; *d.* 2 Aug. 1875.

2. John Lewis, Lieut. R.G.A., *b.* 1 Oct. 1876; *d.* unm. 6 June, 1906.

3. Thomas Herbert Richard, *b.* 2 April, 1885; *d.* 29 Nov. 1916.

Claud Hamilton Vivian (see BURKE's *Peerage*, VIVIAN, B.).

Arms.—Quarterly: 1st and 4th, quarterly, 1st and 4th arg., a chevron sa. between three Cornish choughs ppr., in the beak of each an ermine spot (LEWIS); 2nd and 3rd gu., on a chevron between three bucks' heads cabossed arg. a crescent of the field for difference (ROBERTS of Bodior); 2nd and 3rd gu., on a fess or, between a mullet in chief and an escallop in base arg., three martlets sa. (HAMPTON). *Crests*.—1st, A Cornish chough ppr., in the dexter claw a fleur-de-lis az. (LEWIS); 2nd, A wyvern amidst bulrushes ppr. (HAMPTON). *Motto*.—A Deo et rege.

Seat.—Henlllys, Beaumaris, Anglesey.

MARY, MRS. JENKINSON, of Trehill, Devon, *b.* 5 Jan. 1871; *m.* 26 Sept. 1893, Major Henry Law Acland Jenkinson, R.A., of Alverstone, co. Warwick, who *d.s.p.* 23 Jan. 1902. Mrs. Jenkinson s. her father in 1930.

Lineage.—JOHN LEY, of Trehill, Devon, *b.* 1707; *m.* 1735, Grace, dau. of Henry Grandy, of Exeter, and by her, who *d.* 1772, had issue,
