LIEUT.-COL. THOMAS NOYES, of Westerly, R.I., served in the War of American Independence, President of the Bank of Westerly, b. 1754; m. Lydia, dau. of William Rogers, of Newport, R.I., and d. 1819, leaving with other issue, a son,

DANIEL ROGERS NOYES, of Lyme, Conn., Merchant, b. 1793; m. Phoebe Griffin, dau. of Joseph Lord, of Lyme, Conn., and d. 1877, leaving with other issue, a son,

CHARLES PHELPS NOYES, of St. Paul, Minnesota, Merchant, Banker, and Director of numerous corporations, President of North-West Branch of the American Archaeological Society, President of Minnesota Historical Society, served in the Civil War, 22nd Regt. New York National Guard, b. 1842; m. 1 Sept. 1874, Emily Hoffman, dau. of Winthrop Sargent Gilman, of New York, and d. 1921, leaving issue,

Christopher Russell, 17th Regt., Governor of Minorca, and widow of James, younger brother of Sir John Conway Colthurst, of Co. Cork, by whom he had issue,

CAPTAIN EDWARD OATES, of the British Naval and Merchant Service, Commissariat Dept., who also appears to have commanded a privateer, a very useful proceeding at that period, settled in 1817, in Little York (now Toronto). He built a vessel called the *Richmond*, to run between Niagara and Toronto, and sailed her until 1826. He was b. in Ireland in 1772; m. 1st, Henrietta Andrews, and had issue, one son, Edward, b. in London, England, Nov. 1800; m. 2ndly, Elizabeth Hocking, and d. in 1827, leaving by his second wife, six sons and two daus., of whom,
