

Wit. - Joseph Rosier, Lawrence Washington, John Washington, William Hardige. (Another will showed gifts in italics). There children were lst. Ann, who married John Washington, who imigrated with his brother Andrew to America in 1657. One record states he came in 1656 at the age of 25 years and stayed at the home of Col. Nathaniel Pope. A gift from her father to Ann is recorded in William and Mary Quarterly Vol. 4, page 76. They lived at Bridge's Creek, the family place of sepulture. They had a son, Lawrence, whose son Agustine, born 1694, was the father of George Washington. -- 2nd. Margaret, who married Capt. William Hardidge (Hardwick or Hardridge). -- 3rd. Thomas, Married Joanna - and in 1684 moved to Bristol, England. His will written at the time of sailing from Virginia was dated Sept. 3, 1684, proven Oct. 20, 1685, was probated Jan. 3, 1686. He only lived 16 months after reaching England. Power of attorney 1709 from the contract of Joanna Pope of Bristol, England, widow, to her son, Nathaniel Pope of Pope's Cree -k, Potomac River, authorizing him to manage her plantation called the Clifts. On Feb. 28, 1710 Joanna Pope of Briston England authorized Thomas Wills, merchant & Nathaniel Pope of Pope's Creek, Va., marinek, to dispose of Plantation Clifts (Essex County, Va. records) New England History and Genealogy, Vol.viii, pg417. -- 2nd GENERATION -- 4th Nathaniel Pope, 2nd. born about 1640, died 1675. He obtained patent of land on Hollis Creek in 1661 - transferred it to John Watts in 1665. He married about 1667 Mary Lisson (Sisson), sister to Daniel Sisson, an interpretor to the Indians. Nathaniel Pope II died early without a will, leaving an only son, Nathaniel Pope 3rd. Mary Sisson Pope married the second time to -- Bridges and becoming a widow again married 3rd Lewis Nicholas, by whom she had a son, Lewis. She married the 4th David Whitliffe or Wickliffe, the first protestant born in the province of Maryland. By him she had two sons and one daughter, David, Robert and Deborah. Mary Pope alias Bridges gave calf to her son Nathaniel Pope alias Bridges in 1675. As Mary Nicholas, widow of Lewis Nicholas she made presents in 1677 to her son Nathaniel Pope alias Bridges and her son Lewis Nicholas. She married 4th Daniel Whitliffe, who promised to keep her children "so far at school as to write and reade". Mary Nicholas refers to her brothr and sister, Capt. Daniel Lisson and Jane his wife. On the Jury Aug. 25, 1677 were Daniel Lisson, Original Brown, John Butler and William Hardidge. -- 3rd Generating Nathaniel Pope 3rd, called in records Nathaniel Pope alias Bridges because of his mother's 2nd marriage, was born about 1668, died 1719, married 1690 to Jane Brown born about 1670, died 1752. She was a daughter of Originall and Jane Brooks Brown "Early Immigrants to Virginia" gives William Browne 1654 by Nathaniel Pope, Westmoreland County, Originall Browne 1653 by Col. William Clayborne (Sec. of State) Jane Brooks 1650 by Henry Brooks of Northumberland Co. Nathaniel Pope received deed from his mother Mary Bridges Aug 25, 1676, also a deed from Mary Nicholas, Feb. 20, 1677. A deed was recorded in Richmond Co. in 1702 from Nathaniel Pope of Westmoreland Co., Practitioner at law and Jane his wife, He was the King's attorney for Westmoreland Co. and clerk of Stafford Co. in 1705. He got a patent for land in Richmond Co. Mch, 8,1699 and June 8, 1700. Their children were William Lewis who probably died in childhood), John, Jane, Worden, born about 1700 -died 1749, and Elizabeth. Nathaniel Pope was clerk of the Northern Neck (Proprietor's) land office in 1699. In Northern Neck Land Book of 1700 is a grant to Nathaniel Pope, part of which he assigned to his "brother" Garrard Quigley "who died intest -ate and without heirs" and another portion to his niece Mrs. Alice Lincoln. -- 4th Generation -- John Pope, born 1699, died intestate 1745 in Westmoreland Co. Va. John Pope was a landed proprretor, church wardern, member of the Gen'l assembly of North Carolina, 1742-45. Justice of the peace for Edgecombe Prec't, Chowan Co. 1739. He married in 1721 his cousin Elizabeth Pope, only daughter and heiress of Nathaniel Pope (son of Thomas and Joanna Pope, eldest son of Col. Nathaniel Pope I.). Her mother was Elizabeth Pierce, daughter of Col. William Pierce (who sailed with Gen'l Gates from England in 1609 and was Capt of Fort at Jamestown and for many years a member of the Council of State) and Sarah Underwood, who was a daughter of William Underwood of Rappahannock Co. John Pope secured title to land in Stafford Co. Va. Feb. 9, 1718. He gave deed to Augustine Washington for a mill site at head of Pope's Creek, Sept. 25, 1728, also a deed to land to his sister Elizabeth in 1730. Their children were Nathaniel, John Henry and William. After John Pope's death his widow Married Wm. Wroe.

POPE (3) Nathaniel Pope, one of their sons, born 1729, died Nov. 21, 1806, married Lucy Fox, who died July, 21, 1789. They reared a large family. He moved to Louisa Co. and died at Montpelier Plantation, Powhotan Co. Va. Both were buried in Louisa Co. near crossing of Thompson and Louisa Roada. Their graves are marked by stones erected and inscribed by their son Capt. William Pope. Of the eight children, William and John settled in Ga. - 5th Generation -- John Henry Pope born 1721, died Dec 1763 or Jan 1764. His will recorded Jan. 2, 1764 in Edgecomb Co. (Later Halifax) NC. Married 1745 1st Miss Mourning McKinnie or McKinney, born 1724, died about 1749, daughter of Barnaby McKinney, who petitioned Va. Assembly in 1702 to build a grist mill in Isle of Wight Co. Barnaby McKinnie married Mary (Exum) Ricks. Barnaby McKinnie was a landed proprietor, Justice 172 1722, Com. of peace 1724, Ass. Judge 1725, member Gen. Assembly of N. C. 1735. John Henry Pope and Mourning McKinnie Pope had two children. Barnaby, whose will is recorded in Sparta, Hancock Co. Ga. May 10, 1795, probated 1798 names the following children - Mary Pope, Mourning Curry, Lucy Curry, Martha Gibson, Jane Rucker, Barnaby McKinney Pope and Henry Pope. Barnaby McKinney Pope had a son John of Wilkes Co. Ga. (See records of Ga. Wilkes Co. page 126) List of Capt. & number of men - North Carolina records, page 369. -- John Pope - 120 men, 1763, number of men - North Carolina records, page 369. -- John Pope - 120 men, 1763, signed James Paine, Lieut-Col. -- Estate of Mourning Pope, N. C. State records, Vol. 6, pages 384-481-- Lands devised to Mourning Pope, Vol. 25, page 465. -- N, C, State Records, Vol. 22, page 245, show quit rents of John Pope, Edgecomb Precinct, John Henry Pope, Rev. Soldier in N. C. regiment and prominent officer (Wheeler's History of N. C.) married 2nd, about 1750, Mary Burwell. Their child ren were Burwell (called Burrill), Ensign 1st. N. C. Regt. born 1752, married Priscilla Wooten, Sept. 6 or 8, 1772. Priscilla died Jam 19, 1806. (Thomas Wooten her brother, was original settler of Wilkes Co.Ga. created in 1777 and was a member of Congress 48-1823, 49-1824 ex. 50-1825, 51-1826, 52-1827, 53-1828, 54-1829, 55-1830, 56-1831.-- At some time during the Revolution Burwell was Justice of the peace and a member of the court of pleas & Quarter Sessions for Wake Co. N.C. and was a member of the Provincial Congress of N.C. at Halifay, in 1781-2.. He moved to Wilkes Co.Ga. in 1787, as in July of that year he obtained from the He moved to Wilkes Co.Ga. in 1787, as in July of that year he obtained from the state 1,300 acres of Land in Wilkes Co.Ga.He was a member of the State Senate from Oglethorpe Co. 1794-5, and a member from the same Co. in the Constitutional Convention of 1798. He was opposed to the Yazoo Fraud. He died in 1800. His wife died in 1806. Both are burried in the old homestead near Pope's Chapel, in Oglethorpe Co. Ga. They had three sons and four daughters, three daughters married sons of Abraham Hill, the fourth married - Holmes. The eldest son died unmarrid One married Sallie Davis, and Burwell, Jr. married Sallie K. Strong. Burwell, Jr. was commissioned Brig\*Genl in 1828 and commanded a brigade in the Fla Indian War He died in Athens in 1840. -- Willis Pope, born 1754, died 1798. -- Capt. John Pope, born 1755(1757) married Elizabeth Smith, He died in 1821. They had six sons and two daughters. -- Col. Wiley Pope, born 1758(1762), died 1808(1819) married Miss Polly Hill. They had three sons, and a daughter who married a Hulling. One son married a Callaway, one son died at Schull Shoals, on the Oconnee River. The third son died near Independence, Wilkes Co. Ga. in 1868. -- Henry Augustine Pope, born 1760, married 1st Miss Clara Hill. One daughter and a son Middleton, were left. He married 2nd Mary Bavis. -- Burwell, John and Henry fought in Revolutionary War and were in the battle of Kettle Creek. They were original settle oer of Wilkes Co. Ga. Burwell Pope moved to Oglethorpe Co. created in Dec. 19, 1793 and was a member of Congress 19-1794-5, 20-1796, 21-1797, 23-1799, 24-1799 -- Lamar Knight's "Georgia's Landmarks, Memorials and Legends" states on page 1047 records of the five sons born to John Henry Pope and his second wife Miss Burwell. Burwell, the eldest was born 1751 and was only 12 years old when his father died. Burwell was Ensign of 1st. N.C. Reg. Burwell, John and Henry fought in Revolutionary War and were in the battle of Kettle Creek. They were original Settlers of Wilkes Co. Ga. Burwell represented Oglethorpe Co. created Dec. 19 1793, in Congress through its 19-24 years (1794-5, 1796, 1797, 1798, 1799) while his wife's brother, Thomas Wooten, represented Wilkes its 48-56 years (1823-1831 -- Will of John Pope was recorded in will book DD page 86. This book was burned in office of Lawyer who borrowed it, from before 1779 to 1792.-- Jesse Pope and Jesse McKinney Pope testators on land, May 20, 1786. --Early Records of Wilkes C. pg.248 -Remnant of oldest Beed book not bound pg. 137 Jesse, 2nd son of John Henry and Mourning Pope, born about 1730 in Chowan Co., N.C.7 died in Hancock Co. Ga. in 1820, married about 1751 to Mary (Nancy) Fort, will of Jesse Pope in Sparta, Hancock, Co. Ga. Dec. 17, 1818, probated June 5, 1820, names sons Jesse McKinney, Cullen, Henry, Samuel, Allen and John Pope, daughters Ann Long, Mary Denton, Sarah Trippe, Grand Daughters Mary Weaver and Frances Godwin. Mary Fort was born about 1734 at N.C. and died before her husband's will was made Dec, 17, 1818 and she was not named. Their children were: Samuel - married, had several children - one named Elias. -- 7,

Jesse McKinney, borh about 1755, died 1823, married Sarah (Sallie) Trippe, was SENATOR FROM JONES CO. GA. 1808-1812-13-16-17
Allen married Lily Trippe. Their children were Jesse, Jabez, Burrell, Quinney (McKinney), Trippe, Louis, Sarah and perhaps other girls. Jesse married Leah Latimer, Sep. 22, 1808. -- Cullen or Collin married Mary Trippe (three brothers married three sisters). Their children were: Walter married Catharine Thrash; Columbus married Mary; Cadesman, b. July 1, 1803, d. May 23, 1883, married Susan E. B. Sep. 4, 1819, d. June 11, 1897; Ann R. married Arden Rucker; Missouri married Matthew Miller, Eliza married 1st J. J. Carter, 2nd. J. Collier; Matilda married Isaac Cheney, Louisa married -- Love.
