Also sp. Chambless. John Chambliss, b. ca 1630, was in America as early as 1652, <u>Immigrants into Virginia</u> by Nugent: "May 5, 1652, John Chambliss settled in Northumberland County, Virginia. July 10, 1621, Ann Chambless transported (by Richard Barrs of York County)." Prince George Co., Va. Land Patents, V. I, for 1661 to 1717 lists land in 1680 which bordered on land owned by Henry Chamnis.

Henry Chambliss, b. 1660 Va., d. 1719 Prince George Co., Va., his LWT dtd 10/31/1717 Prince Geo. Co., Va. naming issue: Henry, John, William, Elizabeth, Mary, Ann, Nathaniel, and Jacob. Son, John, inherited the plantation where he lived. Henry Chambliss m. Mary Moore, dau. of John Moore, from Prince George Co., Va. deed: "Agreement, John Moor, for love and affection to my daughter, Mary Chamnis of Prince George County, so that she may maintain me, I give all of my possessions except money owed to me by William Temple, Jr. and some goods and clothes. Mary Chamnis agrees to keep John Moor with competent and sufficient meat, drink, lodgins, apparrell and all other things useful, meet and necessary for him according to his degree and calling, in every respect." Signed, John Moor and Mary Chamnis, wit: William and Samuel Temple, recorded 1/11/1720. John Moor was b. ca 1640, d. 1734 intestate, Surry Co., Va., having issue: Mary, b. ca 1664 m. Henry Chambliss; Seth, b. 4/9/1692 Bristol Parish Register, Surry Co., Va.; and John who m. Catherine, b. ca 1699, their children listed in Bristol Parish Register. www.georgiapioneers.com

Mary Moore m. 2d Jacob Denhart, for the following deed in Prince Geo. Co.: "Jacob Denhart and Mary Denhart, late, the wife of Henry Chambless of Prince George Co., decd, for 600 pds. tobacco paid by John Chambless and Henry Chambless of same county, relinquish all claims to estate of late Henry Chamless, 3/8/1725. "Signed, Jacob and Mary Denhart. Issue of Henry Chambliss and Mary Moore follows:

March 1736 action was brought against Henry Chambliss for trespassing, he pleaded guilty. Thomas Hardy and Frances Epps were on the jury and John Chambliss was summoned as witness. At time of his father's death, Henry Chambliss had Robert Bolling apptd as his gdn.

Elizabeth Taylor Chambliss must have d. ca 1747, for the Bristol Parish Segister begins listing children of John and Sarah Chambliss in 1748. Also, the LWT of Samuel Lee dtd 1759 Prince Geo. Va. named his w. Frances. and children, Samuel, Thomas, Ann Baugh, Sarah Chambliss; grandchildren, Frances Chambliss, Elizabeth Chambliss, Peter Chambliss, Samuel Lee Baugh, Amy Raines, Samwe geoffold hope Alam Baugh, and son-in-law, Shands Raines. Issue of John Chambliss and wife, Elizabeth Taylor:

John Chambliss, Jr., b. ca 1740 Sussex Co., Va., where the family seat was for a number of years. From the deeds, we learn that he was son of John Chambliss of Sussex Co., Va., and that he moved to a plantation in

Cheraw dist., S. C., Marlboro Co., S. C., which his father owned. As per deeds in Sussex Co., some lands of John Chambliss, Sr. were sold to settle some accts. of John Chambliss, Jr. In 1756 and 1757 he was lists as member of Welsh Neck Baptist Church, on Great Pee Dee River, with one, Lucy Chambliss; also, John Littleton. 4/2/1773, he was gtd 250 acre in Craven Co., S. C., South Carolina Archives, V. 28, P. 587.

John Chambliss, Jr. d. before 1777, for his widow, Mary Chambliss, is found in Richmond Co., Ga. deeds of that date, also in 1781 deed Warren Co., Ga. The records of Welsh Neck Baptist Church in Cheraw dist.,

S. C., still show Mary Chambliss a member in 1778, and 7/24/1779, John Chambless, baptised. She moved her membership to Long Creek Baptist Church in Warren Co., Ga., where "Mary Chambliss, Sr. and Mary Chambliss, Jr." are listed as members, 1799-1819, membership rolls, along with Littleton and Christopher Chambliss. Mary Chambliss, Sr. would be wife of John Chambliss, decd. Mary, Jr. would be the dau-in-law of Mary, Sr., the w. of Zachariah Chambliss. Mary, Sr. was prob. a dau. of Saveige and Ann Littleton of Richmond Co., Ga., abt. 1782. The records on Littletons are precarious, but they came from

Accomac Co., Va., thru Cheraw dist, S. C., into Richmond Co., Ga.

The above church record, taken from Warren County History by Wilhelt, V. 2, gives death date of Mary Chambliss as 10/14/1817. However, the Bible of Littleton Chambliss, her son, in possession of Charles Owen Smith of Moultrie, Ga., lists her death as 9/15/1813. Sussex Co., Ga. DB C, P. 79, John Chambits of Sussex Co., Va.,
