Thomas Dunn, b. 1606 England, came to James City Co., Va. in 1620 as a 14 year old servant of Sir George Yeardley. Knight and Governor and Capt. Gen. of Va. In 1623 Thomas Dunn was on the Muster of Persons Living at Flower Dieu Hundred, which was located on southside of James River, being part of Weyanoke Plantation, the home of Gov. Yeardley, situated on border of Charles City Co., later Surry Co., Va. In 1655 most of the territory within Weyanoke Plantation, including Flower Dieu Hundred, was made a part of Martin Brandon Parish in Charles City Co. Issue:

- I. Thomas Dunn, Jr. of Essex Co., Va. m. Elizabeth Gray. His father, Thomas Dunn, was granted 448 acres in Essex Co., Va. in 1699 for bringing nine persons into the Colony.

Yeardley, along with Thomas Dunn, William's brother. William settled in the frontier Parish of S. Farnham in Essex Co. abt 1688, accumulating several hundred acres of land lying both in Essex and adjacent co. of Caroline. He may have inherited some of the Essex Co. land his father, Thomas, was granted in 1699. William Dunn, Sr. d. in 1732, leaving LWT naming his three youngest sons, leaving them 500 acres in Caroline Co. and a gift of one hundred acres to John Williamson, prob. a son-in-law; his personal estate to be divided among his six youngest children, Issue:

It appears that a conflict between Waters Dunn and his father developed over certain debts which Waters made, apparently borrowing three hundred pds from his father and John Edmundson, and on Oct. 28, 1752, Waters signed an Indenture to his father, William Dunn and Edmundson, granting them seven negroes, four beds and effects, together with all the rest of household furniture, ten head of beef cattle, one horse, two mares. Waters Dunn gave mortgage to his father, probably having failed to pay
the debt. Before leaving Essex Co., Waters Dunn held an auction, at which
his father purchased three slaves. In his father's LWT, William Dunn
"lends" these slaves to Waters until certain debts are repaid.
About 1760, a group of families, led by Waters Dunn left Essex Co., Va.,
settling in Halifax Co., Va., and from there to Pittsylvania Co., Va.,
then Henry Co., Va. James and John, sons of Waters' bro., William,
also went. In 1765 Waters bought 405 acres in Pittsylvania Co. He appears
to have accumulated several hundred acres and even though residing in
Henry Co., he still sold land back in S. Farnham Parish, as late as 1779.
The LWT of Waters Dunn, Columbia Co., Ga. he speaks of "the remainder
