Gaorge Lewis, b. 1760/1770, listed 1830 Tattnall Co. Ga. Census. In 1821, he bought from Robt Brewer a tract containing 334 acres in Tattnall Co., wit: Stephen and Hanson Lewis. This same land was deeded to Hanson Lewis by George Lewis on 5/5/1827, wit. Stephen Lewis. 2/7/1841, George

Lewis deeded to Hanson 200 acres on waters of Cedar Creek. In a deed of same date, George Lewis sold all his horses, hoggs, etc. to Hanson Lewis and to Smith Lewis, on conditions that this property was not to go to either of them until his death. He also left gift deed to Cynthia Lewis. Hanson

Lewis, admr. est. of Cynthia Lewis, 11/3/1851, Tattnall Co., he produced LWT of George Lewis into court, however not recorded, Tattnall Co. Invs., Sales, etc. 1850-54, P. 122. On P. 27-8, est. of Cynthia Lewis filed, with notation: "Sale of sundry articles & property of Est. of George Lewis, 3/23/1850. Frederick Holland, admr." P. 83, "Est. Cynthia Lewis, decd, in acct. with Hanson Lewis, admr. from 1/1850-12/31/1850 inclusive...." Issue:

I. Nancy Lewis. Mentioned in est. of Cynthia Lewis, "for board, clothing, maintenance, etc." B. 1800, living with Hanson Lewis 1850 Tattnail Co.

II. Stephen Lewis, b. ca 1795 m. 1815 Celety Futch, Bulloch Co. Ga., listed 1830 Tattnall Co. Ga. Census.

III. Hanson Lewis, b. ca 1800, w., Charity. His LWT dtd 5/18/1875, pvd 1883 Tattnall Co. naming w. and issue: J. P. Lewis; Elizabeth Holland.

Also named grandson, Josiah Holland. His dau., Elizabeth, b. 1828 Tattnall Co. m. David Holland 4/5/1846 Tattnall Co., listed 1850 Tattnall Co. Census.

IV. Smith Lewis, b. ca 1800.

V. Matilda Lewis, b. 1798, m. Frederick Holland ca 1830, Tattnall Co., marr. recorded without date. Issue: Martha Holland, b. 1812; Nancy Holland, b. 1814; David Holland, b. 1816; Polly Holland, b. 1818; and Matilda Holland, b. 1840, all in Tattnall Co. Ga.

Stephen Lewis deeded some land 1/9/1834 Tattnall Co. to Thomas B. Chesser, orig. granted himwiww.deengidpioneers.com/wer.
