Obituaries in the Bible:

Obituary of John Warren Bacon, born Jefferson, Jackson Co., GA 11/22/1824, to Charles Bacon. Charles came from South Hadley, MA in the early part of the 1800's "and gave promise of a very successful business career but died young, leaving a widow and three minor children---John W. Bacon, a sister, and our worthy Ordinary Hon. Joel J. Bacon. Soon after his death, the widow, Sarah Deupree Bacon, sister of Judge Lewis Deupree, removed to Lexington with her children.

In early manhood he fell in love with Mary E. Jordan, daughter of Hon. Henry Jordan, Judge of the Inferior Court of Oglethorpe County...and they were married. The issue of this marriage were several children, all of whom are now dead excepting Mr. Charles Bacon, a prominent and successful merchant of Maysville, GA and Miss Mamie (Mary A.) Bacon, who is widely known through the state as a prominent educator and author.

After the death of his wife...he married Mrs. Caroline Thompson, by whom he had no children....The most successful part of his business career was spent in Marietta, GA where he won the esteem of all for accurate, conscientious and honest business methods. When a mere boy, John Bacon joined the Methodist Church and he was a member of the first temperance organization in the state. On Friday afternoon, December 22nd the public school at Maysville closed for the holidays. There were sixty children pupils of the school. He purchased sixty little Christmas gifts and went to the school and presented each child with a gift making to them a short speech in which he spoke of the importance to children of early fixing their hearts and minds upon pure purposes and honorable ambition

His remains were brought to Lexington and after memorial services were held in the Methodist Church on the 26th of December, were laid to rest in the cemetery at the Presbyterian Church in the afternoon of that day."

Obituary, "Lilla Mary Bacon died in Marietta, GA. Mrs. Mary Elizabeth Bacon died in Lexington, GA, and Lizzie Bacon, who attended the Georgia Normal and Industrial College at Athens, joined the Presbyterian Church in Lexington under Rev. Mr. Green. Her married life was brief but blest with the sincere affection of her husband and step children...."

Origin of the Surname

"Grimbaldus, a Norman gentleman, it is said, came into England at the time of the Conquest, in company with William de Warenne, Earl of Surrey, to whom he was related. He was an early tenant of Letheringsete, near Holt in Suffolk, and married and had issue: Randulph, Edmund and Ranulf, known as Ralph, who resided at Thorp, in Norfolk, and took the name Bacon. His place was called Bacons-Thorp. The family of de Warenne takes its name from the castle of Varenne, called later Bellencombre, on the river Varenne, Department Siene-Inferieure, and was founded in England by William de Warenne, first Earl of Surrey, who held at one time great estates in twelve English counties. He married Gundred, a child or stepchild of the Conqueror, and a sister of Gherbode, or Gerbod, another child of William the First, and was created Earl of Chester.

There are no records in England before the Conqueror, the principal families descending chiefly from the victorious invaders, and no history of any family much before the eleventh century. Joseph Foster, an eminent genealogist, says in reference to the Bacons: 'The early descent of this family, which was very widely spread through Suffolk, is variously set forth, as may be seen on reference to Davy's Manuscript Collections relating to the County.'

In Collectanea Genealogica he has given a long list of the manuscript pedigrees in the British Museum which are of importance to students of this family history (Genealogy of the Bacon Family, Add. Ms. 19,116). The early history of the family is in a state of bewilderment, the various conjectures have been hazarded as to the origin of the surname. Lower, in A Dictionary of Family Names, says that Bacon is a seigniory in Normandy, and that the name is in the Battle Roll. William Bacon, in 1082, endowed the Abbey of the Holy Trinity at Caen, in Normandy (Taylor's Roman de Rou). He also says that from their connection with the Bayeux they were sometimes Latinized De Bajocis. We find that on 22 Oct. 1329, Sir Richard de Bajocis was created a Knight of the Bath, as a Banneret, by Edward the Third. Whether he came from the same family as Sir Thomas Bacon, a Justice of the Common Pleas and the King's Bench, who was created a Knight of the Bath, as a Banneret in 1332, by Edward the Third, is not clear (History of Orders of Knighthood by Nicolas, Vol. III, p. 5). The antiquity of the family is beyond dispute, and there are few houses in the Kingdom more distinguished by the production of eminent and great men. The first name of Bacon known in England was Richard, nephew of Ranulf, Earl of Chester, and founder of the Priory of Poachester in Staffordshire. Among

the defaulters in the Red Book in the Exechequer is Roger Bacon, said to have been a brother of Philip de Colombieres (Taylor's Note in Wace's Chronicle 243). The method of obtaining the surname of Bacon is interesting. Ralph, son of Grimbaldus, was known by his place of residence as Ralph de Bacons-Thorp. The word Thorp is Saxon for village, Becuns-Thorp meaning Beech-tree Village. The early monumental brasses have effigies under trees, an evident allusion to the name.

Sir William Bacon, or Sir Robert Bacon, is taken notice of among knights bearing banners in the reign of Philip the Third of France (1270-1285), and bore for his arms a beech-tree. Roger de Baconsthorp, son of Ralph, was father of Robert, who assumed the name of Bacon, and to make his identity clear during the change of patronymic, was styled Robert-Fitz-Roger (Robert, son of Roger). He was a person of great power, and Anne, daughter of John and Susanna Bacon, cousin of Geoffrey Ridel, Bishop of Ely. This may have been only a resumption of an ancient Norman surname which is still existing in the North of France.

First, I give my body to the Earth to be decently buried and my soul to God that gave it me hoping for a joyful resurrection thro the merits of Jesus Christ my blessed Saviour and redeemer. As for what worldly good it hath pleased God to help me with my will is -- Impr. After my just debts are paid I give to my loving niece, Abygall Burwell, wife of Lewis Burwell of Gloucester County in Virginia the Plantation whereon I now reside and all other lands in Hampton and Benton parishes in York County by mew.georgiapioneers.com.ds Sterling. purchased with all my rights or pretense of right and after her death to her son, Lewis Burwell, Jr. and his heirs forever. Then I give to every one of Major Lewis Burwell's children now living Fifty Pounds sterling to each of them, viz--Nathaniel, Lewis, James, Joanna, Elizabeth, Lucy and Martha.

Item--I give unto my niece, Elizabeth Sherry, sister of aforesaid Abigail Burwell, Thirty Pounds sterling.

Item--I give and bequeath all my lands lying in Isle of Wight and Nancymond Countys in Virginia to my Nephew, Lewis Burwell, Junior and his wife, Abigail Burwell and after their decease to Nathaniel and James Burwell, sons of the aforesaid Lewis Burwell and to their heirs forever.

Item--I give unto my Nephew, Major Lewis Burwell all my lands lying and being in New Kent County to be managed, sold and disposed of to the best advantage and the proper use and benefit of the said Lewis Burwell's four daughters, viz. Joanna, Elizabeth, Lucy and Martha, now living.

Item--I give unto my brother in law, Thomas Burras (Burrows) Berry (Bury St. Edmunds, County Suffolk) in England Twenty Pounds Sterling.

Item--I give unto my brother in law, Wilkyson (Mr. Wilkinson of Burgate) in England Twenty Pounds Sterling and Thirty Pounds to the said Wilkynson's wife.

Item--I give unto Frances Lady Berkeley my riding horse Watts and Ten Pounds Sterling

Item--I give to Colonel Philip Ludwell Ten

Item--I give to the right Honorable the Lt. Governor Francis Nicholson Esquire Twenty Pounds Sterling.

Item--I give to my secretary Cole Ten Pounds Sterling.

Item--I give unto the Parish where I was born Twenty Pounds Sterling to be paid into the hands of my brother Burrus (Burrows) and to be disposed of as he sees good.

Item--I give Hampton Parish in York County in Virginia Twenty Pounds Sterling to be disposed of as the Vestry shall see fit.

Item--I give to the Mulatto Kate her freedom at my decease, it being formerly promised by my deceased wife. It is my desire that Mr.

William Bassett be forever acquitted and discharged from the payment of any Bills, Bonds, Contracts or Debts whatsoever that there shall be found due to my estate at my decease, he giving to my executors hereafter named a full discharge and acquitance from all Debts and demand whatsoever he have or may have against me as I was Guardian and Executor in Trust of his Estate, he giving liberty to my Executor to remove what Estate shall be known to be mine on his plantation called 'Mate-heart'.

Item--My desire is twenty pounds be laid out n Rings to be given to several friends, according to the direction of my executor hereafter named.

Item--I give unto Will Davis my Servant Ten Pounds Sterling per annum for what time he has to serve after my decease to an assistant to my Executors.

Item--I give unto my Nephew Major Lewis Burwell and to my loving niece, Abygaill Burwell, wife of said Lewis Burwell, all my personal Estate and debts due to me either n England or Virginia or elsewhere as also all my ready money: ships or parts of ships and all my goods and Chattels Whatsoever to me belonging in any part of the world not already expressed in this Will to be disposed of by the said Lewis Burwell and Abygaill his wife to the real use and behoof of the children lawfully begotten of the said Lewis Burwell and Abygaill his wife and to no other extent and purpose whatsoever and to be divided between them according to the discretion of their said father and mother or the longest survivor of them.

Item--I do make Major Lewis Burwell and his wife Abygaill Burwell sole Executors of this my Last Will and Testament, hereafter revoking all other Wills and Testaments whatsoever, to the true performance of which I have hereunto set my hand and seal this 15th day of March 1691-2.

Puritans, MICHAEL and JOANNA BACON, born ca 1670, migrated from England to Pennsylvania, then to Dorchester, South Carolina, were the founders of the movement in Liberty Co., Ga. Their minister had acquired large land grants for his congregation in Liberty Co., at Midway. South Carolina Governor encouraged Georgia settlement for these Puritans, because he said that there was a great opportunity in the Colony and fertile lands.

The old Puritan Church at Midway still stands. Midway is half way between Darien and Savannah. It's cemetery which is across the street from the church building, houses its original settlers.

His LWT dated 7/12/1765, probated 2/28/1765, gave wife, Mary, use of plantation and 150 adjoining acres, also five negro slaves, I. E., Tirah, Navo, Will, Came and Robe, which were to be distributed between his children at the death of his wife. Grandchildren: John Golden, Peter Golden, William Bolden, Abel Golden. To his son, John, he left the plantation on which John now lives, also 280 acres adjoining land. His 140 acres, near Dorchester, S. C. was to be sold to pay debts.

Joseph's LWT named his brothers, Samuel Bacon and William Baker, exrs. Issue:
