CHAMBLEES

Perhaps the most authentic information concerning the Chamblee Family, has come from Mrs.Alta Martin Humphrey, of Beinbridge Georgia, who is a great great granddaughter of our progenitor, William Chamblee (1780-185). She has researched this family for many years and documented her findings. In 1937 she talked at length with her grandfather, William Franklin Chamblee (1847-1939) who was able to give her valuable first hand information. She has deposited folders on the Chamblee and Martin Families in the Department of Archives and History, Atlanta, Georgia. In the Chamblee folder is a photo copy of the personal records contained in the Jacob Chamblee Family Bible, which is now in possession of a descendant of William Chamblee (1780-185). Mrs. Humphrey wrote, "It is thought that the father of William Chamblee (1780-185) was Jacob Chamblee who was born Jan.25,1752. The Bible in which this record was found was printed in Edinburgh in 1771. We do not know that Jacob Chamblee was born in Scotland."

From another source, This 'n That, History of Hall County, Georgia by Sybil Wood McRay, page 57~ "According to other family records, Jacob Chamblee was born in Edinburg, Scotland and came to America. He settled first in Virginia and then migrated south and became a land owner in Anderson, South Carolina. He had at least two sons; George Washington Chamblee, who became a resident of Hall Wounty shortly after 1820. He married Christiana Adeline Tanner. He died in 1865 and is buried on his land known as 'Thompson Mill' lower Hall County. George Washington Chamblee was enumerated in the 1800 census of Enderson County. S.C. He and his wife were parents of Elizabeth,

L'vinia, Crissie, and Nysie."

The second son of Jacob Chamblee, William Chamblee (1780-185) was born in Tennessee, and is the progenitor of this Chamblee Genealogy. He married Dorcas Sego, or Seay, in 1806. She was born in South Carolina. William Chamblee was enumerated in the 1850 census of Cherokee County, Georgia, A. son Enoch, age 20, was living with in the home as was Elaine Seays(?) age 87, born in North Carolina. The 1820 census listed the family in Hall county, and it is believed that they moved to Cherokee around . 1834 or '35. There were six sons and four daughters in the family.

An affidavit, made by William Franklin Chamlee, referred to in Haal County History, This 'n That, "deposes and says that there were six Chamblee (Chamlee, Shamblee, Shambly) brothers who came to this country; four mettled in Virginia and two in South Carolina pear Spertanburg."

I am in correspondence with Mr.Bayard V.Chamblee of Hickory N.C. who gives this information about early Chamblees. "About 1770 three Chamblee brothers, Jacob, William and Robin came to America from Ireland or England and located in Virginia. Later Jacob moved to South Carolina and Robin to North Carolina (Wake County), presummably as his children lived near what is now Zebulon. One son located in Guilford County, North Carolina. Mr.Bayard V.Chamblee is the great great grandson of Robin Chamblee who located in North Carolina. He further states that Jacob Chamblee, who moved to South Carolina, apparently located in or near Anderson.

A history of Anderson County S.C., Traditions and History of Anderson County by Louise Ayer Vandiver, page 146, gives an account of Sarah Chamblee who must be some relation to Jacob. "One of the oldest and most numerous families in the County is that of Burriss.------The first of the name to come to Anderson County was Joshua, born in Virginia in 1724. He moved to South Carolina in 1776. His wife was Sarah Chamblee, and they lived not far from where Gluck Mill is now located. They were the parents of seven children, all of whom settled on land given them by their father on Generostee Creek. The names of Joshua Burris' children with the names of the men and women they married: Elisha married Margaret Greenlee; Elizabeth born 1768married Asa Castlebersyja State Account 1776 married Susan Cain in 1794; John born 1776 married Elizabeth Davis in 1796; Mary Burrus, born1778 married LEWIS CHAMBLEE in 1798; Thomas born 1782, married Jane Davis in 1800; Nanoy, born 1794, married Silas Massey Joshua Burris became a man of wealth. the history of our family failed to record much of the records we would like to have. The little that we know was evidently obtained by Uncle Sigma and Aunt Minda (Mrs. Hankins of Winston Salem) sent a copy of it to some and it came to me. That information is valuable,

incomplete as it is. A copy of it will be included in this report. Our Grandfather, William Bryant Chamblee, was married twice. The first wife was Martha Hardy. Their children were Miley C.. Harriett, Mattie, May and William Hardy, our father. The second wife was Nancy Griffin. Their children were; Mike, Rocher, Sigma, Minda, Patty and Johnny. Aunt Minda was the last of both families to die. She was Ninety-six years old. Our Grandfather owned a great deal of land. He deeded the farm that our father owned

For some reason the member of our family who might have obtained information about

to him, possibly, on his twenty-first birthday and he lived on it for about two years, preparit his own meals etc. before marrying the girl he was in love with. He married Ella Etta KIKHARA Richardson whose family lived near Wendell and were distant relatives. Our Grandmother's parents were Josiah Richardson and Tempe Ann Anderson. He was one of

of twenty-five children to Applewhite Richardson and one of his three wives. The members of or Grandmother's family were; Ella, Etta, Helen, Sally, Edward (Ed), Zeb, Joe and Mery. Our mother and her sister younger , Helen, were married in the home in a double ceremony. Aunt Helen married Dr.G.M.Bell and they lived in the small town of Wakefield. Their children and the Our family lived in the not too productive farm and everyone was required to help with

children in our family attended the same school in Wakefield. the farm or house work as soon as they were old enough. The work was hard and there were few luxuries, but there was abundant love and pride. Our parents did what they could to give us th the best education possible. On account of the distance from school and there were always small ones, it was necessary for transportation to be provided. This consisted of a two seated carriage and a horse. We were fortunate in attending a good school. The big problem was to attend some higher school after completing the local school. It

is hard to realize that everyone of us did attend some college or its equivalent. Durward attended Draughan's Business College in Releigh, Sister Clyde went to Baltimore, Maida to Oxford College in Oxford N.C., I(Bayard) attended Wake Forest College, Exum attended State College in Raleigh, Joe attended Wake Forest College and Medical College of Virginia, Estelle attended Westhampton (Woman's College of University of Richmond) and East Carolina, also Atlantic Christian College in Wilson, N.C., Mazelle attended the New England Conservatory of music in Boston. Our Grandfather, William Bryant Chamblee, enlisted enlisted in a company that was

recruited in eastern Wake County and Franklin County. He was offered a commission but refused, but did accept the sergeant's place. He later was commissioned a lieutenant. He served for four years in Lee's Army in Virginia and was wounded near the end of the war near Petersburg, Virginia. His leg never regained its full use as the result of the minie ball and, doubtless the poor medical care he received in the hospital in Richmond. He used a crutch the It will be only right to mention "Uncle Jem Chamblee" (slave). When Grandpa was leaving

remainder of his life. to establish a home for himself, his father told him to select one of the young boys to serve as his personal servant. He selected Lem and as long as he lived Lem was not only a faithful servant but a dear friend. When he went off for war he told Lem hewas leaving all that he held dear and all that he owned in his care. Lem was faithful in everything. Our father was born while Grandpa was away and the wife, Martha, died and he arrived home on "compassionate leave" after her death. Uncle Lem lived until his death on a farm Grandpa sold him cheap and all of the family

Another history, Journeys into the Past, The Anderson Region's Heritage by Frank A.Dickson, page 44, gives an interesting story concerning a Zadoc Chamblee. "Book S, pages 172-173 in the clerk of court's office at the courthouse, Anderson S.C. contains the report that Gambrell submitted on March 31,1827: Agreeable to the direction of the commissioners appointed at the last session of the Legislature of the State of South Carolina to select a site for the public buildings in Anderson County, I have measured the land and I find that Manning Poole has 64 acres, Hezekiah Rice has $26\frac{1}{2}$ acres, William Magee $23\frac{1}{2}$ acres and ZADOC CHAMBLEE 10 acres, each parcel being represented in the above plat." The plat is on record in the courthouse showing approximately 124 acres, but 130 acres were actually purchased at \$4.62\frac{1}{2}\$ per acre.

There is another story about ZADOC CHAMBLEE related in the History." Judge Whitner moved to Anderson in 1830. Out a little to the west of the new town lived a man named Zadoc Chamblee. His house, built of hewn logs and covered with oak boards, crowned a beautiful knoll. Judge Whitner bought the place, and used the strong log house as a nucleus for his own dwelling, which was considered a very fine mansion when completed He weatherboarded over the logs, added rooms, piazzas and pillars, until the house assumed much its present appearance---. Mrs. Whitner, a flower lover, had the whole hill planted in roses, and named the place Rose Hill."

I can only assume that all these CHAMBNETSOUGHROUSE ,or at least, related families because of the spelling of the name, their coming from Virginia and all locating or passing through Anderson South Carolina.

KNOW YOUR NAME by John C. Downing, from Atlanta Constitution CHAMBLEE

This English place name was acquired from once having livedin Cholmondele, pronounced Chumley, a township in Cheshire, or at Chulmleigh, a parish in Devon.

The Chechire place was spelled Colmundelei in the 1086 Domesday Book and Chelemundeleg in 1287. The meaning is "Ceolmund's meadow." Colmund is probably an old English compound name incorporating the Danish Kola, a sea god, and the old German Mund "protection" and had the general meaning "protected by Kola". The Devon place carried the same meaning.

Hugh of Chelmundeleg was listed as living in Cheshire in 1283. Roger Chomley, lis

listed in the York Gwild Rolls of 1493, was probably the son of Sir Richard Chomley Thomas Cholmeley and Dorothy Bedle were issued a marriage license in London in 1566. Richard Cholmondeley of Eccleston, Cheshire, died in 1593. Edward. son of Henry Chomley was baptised in St.Dionis Backchurch, London 1650.

William Chombley and Susanna Chumbly, widow, were buried in the St.Dionis Back churchyard in 1668 and 1669 respectively. John Chumley and Alice Todd were married in St. George's Church, London 1720.

Jacob who moved to South Carolina apparently located in or near Anderson. There are many Chamblees living there. I (Bayard) have met several people from that section and everyone spoke h highly of these Chamblees. I met one, Fred , in Asheville who was from Anderson and was the S Superintendent of a large dairy farm. A lady living in Hickory and from Anderson said her Aunt married A Chamblee.

The brother, William Chamblee, is believed to have moved to Georgia. There are a great many Chamblees in Georgia and Alabama. One, a Dr. Chamblee, was President of Bessie Tift College in Forsyth Georgia, one of the WWW GOO THE Colleges in Georgia. There is a town just outside of Atlanta to the north, named Chamblee. It is now essintially a part of Atlanta.

On account of the great number of Chamblees in Georgia and Alabama, it is possible that some other Chamblees came over from England and settled there. We have no record of such. The following is copied from the Historiography of the "Chemblee Coat of Arms." The

surname Chamblee appears to be locational in origin. It is believed that it is associated with the English meaning. "One who came from Chalmondelay." The most different spellings of the name me; Chambley, Chambly and Chamley.

Another possibility is that the name migrated to the British Isles from France, where the name is both a family name and a place name.

Note: Quite by accident, through a mutual friend, I received the address of Mr. Bayard and followed up with a letter. He too is interested in genealogy, Chambles genealogy in particular, and sent me in a few days the information found above. Am now in the process of getting our story to him. This is the way it is done.

WILLIAM CHAMBLY 1780-185

William Chambley(1780-185) married Dorces Sego(Seago) of South Carolina, whose father Was Robert Sego (1754-1810) and, according to Dr. Aquila Chamlee, was a captain in the army of either 1812 or 1776. Since he died in 1810, it would have been the Revolutionary War. Her mother was Elender Wharton Sego (1764-185). The Selos came into North Carolina from Maryland and then on down to South Carolina about 1765 or 1770. Robert Sego died in Anderson County S.C. and it is thought that Elender Wherton Sego died in Cherokee County, Alabama, where she was living in the home of her son, Robert Sego.

William and Dorcas Sego Chambley had 10 children: Martin, Tillman(1809-1887), Jarrett, Robert, William, Enoch, twins Lucinda and Polly, Jeanetter, Dorcas. They lived in Hall County, Ga. and probably never owned a farm until after the Cherokee Purchase, He bought a home near Hickory Flat in Cherokee County, Ga. and was enumerated in that in the census of 1850. Living in the home was Engch, age 20, and Elaine Seay(Sego) age 87, born in N.O.

The tale is that Tilmon and his bride, Kindness, moved to Cherokee Co. with mule, gun, frying pan, ax, and sheepskin blanket. He secured a tract of the Cherokee Strip land from the government, and added to it by purchase, eventually becoming the owner of a valuable farm. He was appointed U.S. Judge of the Inferior Court of the District, and thus became its youngest Judge www.georgianinneers.com Tilmon Chamlee--1841-1843;1855-1857

1857-1860;1861-1865 (Hist.Hadrokee Co.-Marlin) It is told that the Chamblee name lost its "B" due to the many signatures required in the execution of his official duties, in fact has name changed from Tillemont Chamblee to Tilmon Chamlee.

Tilmon Chamlee, the second child of William and Dorcas Sego Chamblee, was born near Walhalla S.C., 1809 and died in Cherokee Co.Ga.1887. Both he and Kindness were buried in the family cemetery on their old home place on the Ettawa River.

According to photostats sent to Dr. Aquila Chamlee, May 29, 1962 by Fred Bell, the 10 children of this couple are as follows.

The publication "gone to Georgia" states that the Light Family is found in various po of South Caroline in 1790, and Obedieh Light drew land in the 1895 Jackson Co. (Ga) lottery

The 1620 federal census of Hell "ounty enumerates Obedieh Light. In 1843 Obadieh took a land lottery oath: "Forsyth Co.Co.Before me B.J.Rice a J.P. for said county persons came Obadiah Light who being duly awarn ... that he is proper agent appt'd the heirs of John Moore dec'd to Grant Lot 4 in 27th Dist. of 3rd section of originally Cherokee, now Welker County Dated 29 May 1843. Signed Obediah (X) Light. On May 29, 1843 Obediah Light appt'd Raymand Sanford of Hall County his lawful agent to apply for said grant in presence of Joseph Martin and B.J.Sice, J.P.

Obadiah Light was born in the 1700's and according to Bable records of the Light family, died in Hall County or Foreyth County, July 30, 1849. He was married to Mary Moore on Cept. 23, 1603. Mary Moors was born March 12, 1769. Her perents were probably John Moore who was born Oct 25, 1757(1757) and Mary Meller Moore born Oct 3,1759. One John Moore, Revolutionary Veteran and resident of Hall County, drew Cherokee County land in 1827 which was granted to him 1843.

George Washington Chamlee, the 5th child of Tilmon and Kindness Light Chamlee, was born 4-3-1840 in Cherokee County, Ga. and died in Atlanta Ga. 1923. He married Malinda Robertson 3-6-1862, she born 2-11-1844, died 6-9-1927. They lived at Keithburg, Ga. five miles north of Canton in the Canton District.

Grandpe Chamlee acquired a large farm and ran a grist mill on Chamlee Creek. All femily members seem to remember the mill, in fact, Uncle Doc. (Son Allen Keith, 1877-1948) had a picture of the homeplace and mill copied by a Sperta artist from a photograph, and it hung in his home in Sparta. It is now the prized possession of his daughters, Venia Chamlee and Benita Chamlee Taylor, both of Fort Valley, Ga. It was said that the cogs of the wheel were made of wood and fastened with wooden pegs. For his milling services, Grandpa Chamlee was paid in kind which resulted in toll corn to excess. To get rid of the surplus corn meal, he applied for and was licensed by the U.S.Gov. to make whiskey. This proved to be a fruitless though leggtime te endeavor, because bootleggers undersold him and he was soon out of business.

There were 13 children born to this family, nine of whom were sons. Emory died in infancy but the others lived to adulthood. There were four daughters, Victoria Augusta Chemlee (1863-1945) who married John Keith and lived in Selma, California; Nancy Luvenia Chemlee (1867-1949) married Rev. John Henry Johnston who was both a teacher and preacher, she was a Postmistress in Atlanta; Malinda Chamlee (1883-1965?), worked at State Capitol for many years; Mae Chamlee (1888-1939. Of the sons in the family, 2 were farmer-merchants, 1 insurance, 4 were lawyers, 1 realestate and 1 a minister. George Washington Chamlee gave his children a common school education and after that, by their own efforts and by helping each other, they managed to gain further training and all became useful, selk sustaining citizens. The family of George Washington Chamlee & Malinda Robertson Chamlee

George Washington Chamlee (4-3-1840-1923) married Malinda Robertson (1854-1927) on March 6, 1862. He always called her the "prettiest girl in Georgia" and she must have been ...even when she was an old lady she had a beautiful complexion and and lovely blue eyes. I never saw my grandmother angry or heard her raise her voice; and, when grandpa became upset and gave anyone an ultimatum which she thought severe she just said- softly- "Now, Mr. Chamlee" and that ended all discussion. They lived on a farm some miles out of Canton, Georgia, in a big white farm house. Goldie Keith told me that her Grandfather Keith built the house. There was a meandering little creek below the house where the grist mill was located and we children used to love to play in the creek. When I was a child Uncle Jerry ran the mill and I will never forget the wonderful smell of that old mill. Every so often the creek would flood and wash away the mill race, then some of the sons would come down and help Jerry restore it. One summer Uncle Quill came with the others, and I was amazed to see that preacher shuck off his coat, but on old clothes and work right along with Jerry and the others. He never knew how much my feeling of respect and admiration for him zoomed up. That was when he became a remarkable man and not just my uncle. Grandpa fought in the Confederate Army for four years, less the last two months of the war, when he was captures is pieces come to love to hear him tell of the places he had been .. he was in very many of the big battles. During the last part of his life when he was old and ill, he suddenly remembered that he had left two damn Yankees tied to a tree and he had to go and turn them loose ... at that time some of the men of the family stayed with the family to help Aunt Linda cope, and after persussion failed one of them agreed to go with him to release the men. I believe this chore fell to my brother George .. at any rate, Grandpa wouldn't take a cab - said he had to walk to find the place and he walked his companion to Grant's Park (some 3 miles, I believe) but the three Yankees were gone and that relieved his mind. He was quite a man, our Grandpa. He once told me that his ancestors came from England, but were originally from France. There is a town or city in France named Chamblee - I discovered it on an old map many years ago and Owen says it is still there. He was never in that part of France during the war and wanted to go to see it when he was there some years ago, but since he was on a tour he was not permitted to leave the group.

Uncle John had been to France - I think before he was married - and he brought the most beautiful blond doll, in a glass case, to May. She was a small child and was not allowed to play with it so it was hung on the wall, to be admired only. I envied her with all my being but had it been mine the story would have been different! I wasn't a meek little girl like May. I've always wondered what became of it and finally got the idea that they gave it to Louise, which would are been a natural thing to do. I think Uncle John and Aunt Lena lived with them or had an apartment in their house, to be corceous State Are treat changes were born they were plentifully supplied with baby sitters. Uncle John and Aunt Lena had been

married many years when Louise was born.

They first had twin daughters - Candace and Frances, who were several years older than I, and who died in the flu episomic of 1918. Their other daughter, Goldie Keith, is now 80 years old and is unmarried. She still lives in Selma, California.

John Bell Chamlee (1864-1945) married Nancy Lena Jones from 2. near Emerson, Georgia. He was in the real estate business. They had only one child - Louise Chamlee (6-11-1910 who is is unmarried and lives in Atlanta, Georgia. 3.

Tilmon Perkins Chamlee (1865-1902) married Alta Foster Shelton (1872-1930) June 5, 1894 in Chattanooga, Tennessee. Her parents Azariah Shelton and Harriet Carper Shelton were members of a pioneer Tennessee family, having moved to the Chattanooga area when Chattanooga was known as Ross's Landing (John Ross was an Indian Chief who had lived there for many years). The Shelton and Carper families were neighbors at a little place called Silverdale and Azariah and Harriet were married when he was 18 and she 14 years of age. Harriet was the youngest of 11 children of Joseph and Elizabeth Carper, and her mother, who was a widow at that time, gave them a farm with a house on it as a wedding present. Azariah farmed for some time and then commuted weekly to Chattanooga where he taught school and was later Supt. of Schools; then he was Sheriff of Hamilton County, Tennessee; then Tax Assewyor Top many, many years. I could write a whole book on Miss Harriet .. her sisters were grown and her only playmates were her two young brothers Joe and Alex and their adventures were almost beyond belief. Azariah and Har let finally moved into town and built a large house on Walnut Street, where they lived for many years. They sold the

Silverdale house to his sister, our beloved Aunt Sallie Friar, where George and I had many happy visits. CLA. Children of Tilmon P. Chamlee and Alta Shelton Chamlee were: Grace Shelton Chamlee b 6-11-1895 (you have details)

Nancy Luvenia Chemlee (1867-1949) married John Henry Johnston who was in politics of some kind-this was before my time, and later became a preacher. Inactive in both of these lines at the time I knew him. Aunt Venia was the Post Mistress at Fort Oglethorpe, Georgia for many years. Their only child was Glenn Johnston, who eventually moved to New York. I don't know what his work was exactly but it was with different magazines. Apparently in management for he was connected with Cosmopolitan at one time. He married there and they had one daughter. All three are dead now.

Acquilla Chamlee - you have all the details on this one.

George Washington Chamlee, Jr. (1871-1958) married Sallie Palmer, of Charleston, Tennessee. I adored Uncle George .. he and my father and Uncle Kell were law partners. My father went to Chattanooga, and then Uncle George joined him, and fina ly Uncle Kell. Their only child, a son named G. W. Chamlee, Jr. and called G.W. is also a lawyer. You have details on him and family.

Robert L. Chamlee (1873-1914) was also a lawyer and lived in Rome, Georgia until his health failed and his doctors sent him to Phoenix, Arizona where he lived for many years. He and I carried on a correspondence and I think my love for that Western country grew out of his letters. He never married.

Keller Franklin Chamlee (1875-1901) also became a lawyer and was a partner of his two broth-rs. He was so young to die .. was well liked by everyone .. a friendly young man. He never married.

Allen Keith Chamlee (Dock) (1877-1948) married Berta Ivey. You have the details.

Alexander Stephens (Beck) Chamlee (1879-1942). You have the details on this one, except that he was another of my loves .. an outgoing, friendly man.

Jerry Werner Chamlee (1881-1938) married Nelle Michael of Athens, Georgia. You have detrils. Another of those lovely Chamlee men.

Malinda (1883-) she stayed with us one year and went to school. Used to tell of dropping me when I was a baby and nearly scared the daylights out of her and she cried worse than I did. She was quite a beautiful young lady but never married. Was a secretary for the Atlanta Red Cross at one time.

Emory (1885-1886) Emory was the little baby that died.

May (1888-1939) - closer to my age .. we fussed a lot. We were both a lot like Mr. Grandpa, as Aunt Linda called him, but we were really very fond of one another. May was never very strong but she kept house while Linda worked. My grandmother Chamlee was blind for many years so the girls had to take over the household duties.

Personally, I think my Chamlee grandparents raised a remarkable family ... some of the nicest people that I have ever known. Each of them blessed with a wonderful sense of humor, with a love for one another, and great compassion.

The letters are faded, very hard to read but they tell so much about this man. His son, Allen Keith Chamlee, said that, "He was the King Bee of the bunch, the Hon.G.W. Chamlee Sr. who did more for his family than any other citizen of his day and locality."

Atlanta, Ga. Sept. 16, 1918 Mr. G.T. Chamlee, Nogales

Dear Son; I almost lost all hope of ever hearing from you any more, but as long as there is life there is hope. I wrote to Grace 3 times since she had a boy at her house, but she never writes to me anymore. Your Uncle George has been elected States Attorney for Chattanooga. He gets salary of three thousand dollars and holds-----If you can stay on the Border as long as the war lasts, my advice to you is to stay there some-----hurt in France, before Germany is put down, if they will let our boys over there they will fetch them to terms. We have got the best army now that ever was on the face of the earth, men from 21 to 31 years ole and nearly 2 million over there. There was a policeman here night before last, he says he saw a balloon pass over the City, it done no harm that I have heard of, his pants may had to be washed, I can't say. I suppose you know your grandma's eyes both has been taken out so she is blind, but it is in good health, eats and sleeps well, is nearly as heavy as she ever was. I have no disease of no kind that I know of, but my powers are gope, I can't do but little before I give out. I have fall off about 30 pounds, I have no appetite to eat is one thing that ails me. Your Aunt Victory Keith lives now on 1609 Grove St., Selma California, if you will write her at Grove St. she has 3 girls all single -- and you will get an answer at once. You might get a chance to visit them. You write them, they are Rich and can do you a favor if you should want one. I have but one thing to be proud of www.tgeorgiapioners.com I raised as nice family of childr as there is in the world. Your Aunt Venia was here yesterday --- have Post Office at McPherson----her son is married and is somewhere in N.Y. State on Long Island. Well George, I will try to write you some more Now I have got back. My mind is so scattering I leave out words, you must excuse me for it is the best I can do. I often get lost in the center of the City, my weakness of body is the cause of my mind being so weak. My sister, Tom Bell's wife (This was the youngest child of Tilmon and Kindness Breedlove Light Chamlee, in fact she was the 10th child. Her name was also Kindness Breedlove Chamlee born 12-8-1855, married Tom Bell Aug. 22, 1872. They had 12 children, 9 boys, lived in Cherokee, Co. About 1905 moved to Worth County, owned a large farm. See names of her family sent to Aquilla Chamlee by her son, Fred Bell.)

Atlanta, Ga. March 29, 1919 Dear George T.Chamlee Fort Blias. El Paso, Texas (Grandpa was 79 at this time) Dear Son, I hardly know how to write you or what to say you have been gone so long from Atlanta. Your Grandme has been sick but is better now, we had a doctor with her. Your Cousin Canny Keith died the 19th of Feb. in Selma California with flu. She was one of your Aunt Victoria's twin girls. The other twin is still down sick with the same disease. (She died also) Your Aunt Mae has been in bed all this week. Your Uncle Allen Chamlee and wife Berta is here with us, one is here all this week. Your Ma sent us a box of oranges and grapefruit some days ago. I sent her a box of apples she wrote that she had got them and they did eat them. Your Uncle Warner Chamlee was here for awhile last night, Your Aunt Malinda keeps well and works all the time. She is making 90 odd dollars a month now. When you get out if you will come and stay Weith Whyradwill try to get you into some good job here. I getting to be very feeble Next Thursday I will begin my 80th Year, my 79th will be out then. Your Grandma was 75 the 11th of Feb. past. We have been married 57 years the 6th of this month. A long time to live together only a few ever live together that long. How long have you got to stay in the army before you get out. When you get out I want you to come by here as you go to see your Ma and stay with us awhile. Glenn Johnston is in New York, is married, got a baby girl at his house, so you see he has something to play with him. Write soon. Asre(The "AS ever your servant") G.W.Chemlee

May 18,1919 As I am writing your Aunt Berta, I will wish Dear George T. you to know that I have not forgotten you and how glad I am that you are where you are. If you will conduct yourself right and stay there, you will have home as long as our uncle lives. He is competent to to advise you on all matters and he will show you how to save your money. When he started out he had nothing and he went to and stuck to it, saved what he made and now he is independent and able to stay at home. I had a letter from Grace and the picture of her son, he looks like he might make a man some day. I would love to see them all but they will have to come here if I ever do. My days are about spent, I never got to go to school only to learn to spell, write and count -- that was the limit of my schooling. I told your Grandma when I got home out of the war(Civil War, 4 years, was captured lest 2 months) that when our children got big enough to go to school, if I ---- enogh to send them and had the mpney to pay for it, I was going to send them if I went to the Pauper Farm to be buried and I done it. We had one teacher at Canton that I paid a salary of 75 dollars every year for 5 years, kept a wagon and tram to haul the children 32 miles- bought their books, clothes, and fed them. It took all I ever but I am glad I did it. I can show as nice lot of children as can be found the world over, something; I am proud of. I don't mind what I have done, it tells for itself. Write to us and come to see us. Asevr(The "AS ever your servent)

Tilmon Perkins Chamlee, born 1864, died Aug.5,1902, was the 3rd child of 12 born to George Washington Chamlee(1840-1923) and Melinda Robertson Chamlee(1844-1927). He was the oldest, and first of the four lawyer sons in fact he "read law", passed the bar and opened a law office for himself. Later, three brothers, George Washington, Robert L., and Kellar T. joined him.

Tilmon P.Chemee served as City Attorney of Chattanooga, Tenn. and at one time received the democretic nomination for N.S.Congress. There was no Republican Nominee so that was tantamount to election. He did not serve in that capacity however, because of ill health. These

Three brothers of the law firm contracted tuberculosis from a friend, who also "read law" in the office and all died at early ages. Kellar died in 1901 age 26, Tilmon P. in 1902 age 37, and Robert(BOb) in 1914 age 41. All sought help by going to Arizona for the dry climate, but to no avail.

Tilmon P.Chamlee married Alta Foater Stelling Chattanooga, Tenn. born 12-24-1872, died 10-5-1930, daughter of Azariah and Harriett Carper Shelton of Hamilton Co. Tenn. At one time Azariah Shelton was a Teacher, Sheriff of Hamilton County and always an influential republican politician.

Surviving Tilmon was his widow, Alta Shelton Chamlee age 30, a daughter, Grace Shelton Chamlee age 8 and a son, George Tilmon age 3. After some years, the family moved to Florida where Shelton relatives were already living.

Grace Chamlee later married Albert Owen Kreigsman of Eustis Fla. and from there George Tilmon enlisted in World War L. Much to his chagrin, he was stationed on the Mexican border for the duration. When the war was over, he came to Sparta, Ga.

Tilmon P.Chamles and Altan Chamles are huried in Forest Hills Cemetery, Chattanooga, Tenn. as are other family members; Robert L.(1873-1914), Kellar T.(1875-1901), George Washington(1871-1958) and Sallie Palmer Chamles (Mrs.Geo.W.Chamles).

G. W. Chamlee, 85, Dean of Bar, Dies. (Chattanooga Times - 1-18-58) Lawyer had been District Attorney General - Rites at 10:30 this morning. George Washington Chamlee, 85, dean of the Chattanooga bar and a former district Attorney General, died yesterday morning in a local hospital. He resided at 1409 Lexington Ro. in Riverview.

Gen. Chamlee was active in the practice of law until the recent illness which led to his death. He was associated with his son, George W, Chamlee, Jr. His name was No. 1 on the chancery court docket indicating that he had practiced longer than any living attorney in Chattanooga.

Funeral services will be held at 10:30 today at the Turner Funeral Home, with Dr. Carl J. Giers officiating. Burial will be in Forest Hills Ceretery.

Pell bearers will be members of the Alert Bible Class, the Chattanooga Bar Association and the Chattanooga Helf-Century Club. The family asks that flowers be omitted.

Mr. Chamlee was born near Canton, Georgia on January 30, 1872, a son of George Washington Chamlee and Malinda Robertson Chamlee. His father was a veteran of the War Between the States.

Mercer Graduate Gen. Chamlee was a graduate of Mercer College in Macon, Go. taking his law degree there in 1891.

He came to Chattanooga and in 1893 joined with his late brothers, Tilmon P. Chamlee, Robert Chamlee and Keller F. Chamlee in the practice of low. It was the beginning of a brilliant career at the bar during which he became widely known both as an able prosecutor and resourceful defender.

He once boasted that he had represented more than 800 persons charged with murder and that www.geographoneers.com represented was ever executed, Gen. Chamlee had a part in the defense of the nine negroes in

the famour Scottsboro case.

During the Prohibition era, he became famous for his defense of hundreds of mocnshiners when U. S. District Court was held in the old Federal Bldg. on 11th Street, now occupied by offices of the Tennessee Valley Authority. It was during this period that Gen. Chamlee narrowly escaped injury when caught in the line of fire between two principals in a moonshine trial who shot it out following the hearing. He served for three terms as city attorney of Chattanooga in

1902, 1904 and 1906. He was elected attorney general in 1918 and held the post until 1929. He served as special judge in various courts during his life.

Mr. Chamlee wrote the city's first ordinance creating a food inspector. Around the turn of the century, when Chettenooge suffered a severe smallnox epidemic, Mr. Chamlee insisted upon erection of an isolation hospital on Willow Street. The hospital later treated 1,100 patients in one year.

On Draft Board The attorney was an associate member of the draft board in 1918. He had served as chancellor commander of Damon Lodge 2, Knights of Pythias, and as a representative to grand lodge on several occasions. He was a member of Sun Lodge, Independent Order of Odd Fellows, Patriotic Sons of America and Sons of Confederate Vetersns.

He was a member of the First Baptist Church, having joined in He was a member of the Chattanooga Half-Century Club.

Mr. Chandestakedroprectodes Collegionin Tennessee, Georgia, Alabama, Mississippi, Louisiana, Ohio and Florida, as well as in Washington, D. C.

He was a member of the Chattanooga, Tennessee and the American Bar Associations.

During the last years of his life, Gen. Chamlee paid tribute through letters to the Editor of the Chattanooga Times to other members of the Chattanooga Bar following their deaths.

Mr.Chamlee was married to the former Sallie Palmer of Charleston, Tennessee on Nov. 2, 1898. She died on Aug. 21, 1951.

Survivors, in addition to his son, include two granddaughters, Marye E. Chamlee and Sally Katherine Chamlee.

Dean of the Chattanooga Bar, George W. Chamlee, who died yesterday at 85, practiced law here for an amazing 65 yearswandgwangiapidaagsacdwefore that in his native Georgia.

A familiar figure in black and umbrella always in hand, he passed on pleasant reminiscences of the past to colleagues and friends at the courthouse while carrying on for clients. He left the unpleasantness aside and several years ago he wrote: "Chattanooga has the best climate in my opinion in the world; the bestneighbors, best Christians, best and friendly fellowship in the country; less racial prejudice than at most places; all apparently willing to let each other worship according to the dictates of his own conscience."

In later years, with regularity, Gen. Chamlee wrote of the "Icy cold hand of death" being laid upon passing Chattanooga lawyers. But, he wrote of them with warm warmth and affection. There are many who will remember his long years among us, and find it hard to picture the scene without him.

It is a well attested mexim that the greatness of a state or of a community lies not in its machinery of government but rather in the sterling qualities of the individual citizen, in his capacity for high and unselfish effort and his devotion to the welfare of his fellowmen. In these particulars, he whose name appears at the head of this review has conferred honor on his community and dignified his calling, so that it is entirely consonantthat a resume of his career should be incorporated in the permanent annalc of his state, in the religious and educational life of which he has long been a conspicuous figure. Aquile Chemlee was born at Centon Cherokee County, Beorgia, on the 3rd of December, 1869, end is a son of George W. and Malinda (Robertson) Chamlee, both of whom were natives of this state. The father was a soldier in the confederate army during the Civil War, belonging to the famous Phillips Legion. His fether Timman Chamlee, was a native of Cherokee County, the son of a native of this state, and the grandson of a native of South Carolina. The family originally came from France and was identified with the war of the revolution. John Robertson, maternal grandfather of Dr. Chemlee, was born in Georgia, while the two generations preceding him were natives of South Carolina, their emigrant ancestor having come to this country from Ireland. Aquila Chamlae received his preliminary education in a private school and then attended Atteways Academy, at Canton. He then entered Ottawa Institute, a public school, after which he matriculated in Mercer University, where he was graduated with the degree of Bachelor of Arts in 1895. He then entered the Southern Baptist Theological Seminary, where he graduated in 1897 with the degree of Graduate in Theology. In 1898 he became pastor of the Sandersville Baptist Church, together with see several other churches, to which he ministered for seven years, and then for four years he attended to the spiritual affairs of the Sandersville church alone. He next became pastor of the Saptist church at Forsyth, remaining there fpr five years going from there to the church at Control big de on Cors Commune 1, 1914, he became pastor of the church at Hawkinsville, where he enjoyed a very successful pastorate until July 1,1922, when he became president of Bessie Tift College, at Forsyth, which position he is still filling with ability and success. Dr Chamlee took an earnest part in various activities growing otu of the World war, serving on a number of committees, on the Red Cross board and the Food Administration. He has always been a democrat in his political belief, while fraternally he is a member of the Free and Accepted Masons, in which he has attained the Royal Arch degree. He also belongs to the Independent Order of Odd Fellows. On September 6, 1898, at Tenille, Georgia, Doctor CHamlee was married to Miss Memie Louise Beck, the daughter of Rev. Thomas Jefferson Beck, a minister of the Beptist Church and the son of a Baptist minister. The Beck family is of Scotch-Irish origin. Mrs. Beck's mother was Elizabeth McKeever, served as bridesmaid at the marriage of Senator Becon's mother. The family lived in Liberty county in early days. The mother was a student in Mercer University duringthe Civil War and seng in the choir. Among others who sang in that choir were several men who later became noted in their several spheres of endeavor. Thomas Jefferson Beck served as a chaplain in the confementate army and is stil preaching at the advanced age of eighty-eight years. To Doctor and Mrs. Chamlee was born one child, Mary Beck, who died at the age of two years. Doctor Chamlee possesses to a marked degree the essential qualifications for such a position as he now fills, being a well educated and cultured gentleman, consecrated to the work to which he has been called, end his success in directing the affairs of Bessie Tift College has abundantly demonstrated the wisdom of his selection. He is of a geniel, social nature , full at times of a quaint, homely humor; he loves young people and many a young man a and woman have been helped and encouraged by him in starting out in life. in 1847, chartered in 1849, and became the property of the Baptist Convention in 1898. In 1907 the present name of the institution was adopted in honor of Mrs. Bessie Willingham Tift, who, with her husband, was one of its greatest benefactors. In 1864-5 the college buildings were used as a Confederate hospital. For three years from 1879 to 1883 the college was suspended three years on account of fire having destroyed the buildings. The Georgia Baptist Convention functions in the realms of higher education of women through Bessie Tift College, which the Gonvention ownes, directs and supports. The college is embitious to give to every young woman who attends its classes a comprehensive knowledge of the word of God and the ability to apply intelligently the life-giving principles of the Christian religion to any group with whom she may be enabled to work.

Recollections of Lillie Archer Chamles January 5,1971

Dr. Chamles retired from the presidency of Tift College in 1938 and from this time until 1952 he held pastorates in the vicinity of Fort Valley, where he made his home. Aunt Memie died in 1948 and he continued to live with her widowed niece, Mrs. Bessie Mershal Johns. After 1952 he devoted his time to interim pastorates and supply work. Mr. Jack U.Harwell interviewed Uncle Quill on the occasion of his 90th birthday Dec. 3,1959 and the Christian Index carried two full pages of his reminiscences of seventy years of Southern Baptist endeavors. He died in 1966 or 67 and was burled in the Beck commetery, Tennille, Georgia.

Dr. Chemlee and I went to Bessie Tift the same year, 1922, he as President and I as an humble freshman. I recall that when I was a senior and President of the Student Council, L headed up a committee which carried a very weighty problem to him. The rule required no candy making in rooms at certain times and we had apprehended Ieslie Williams making same in her room, and the Council had promptly restricted her, which meant among other things, that she could not have compeny on Sunday afternoon. Her father was wealthy and it was rumored that he was on the verge of gifting the college with \$25,000 (as I recall). Dr. Chamlee (probably didn't know she was restricted) inadvertantly told Mr. Williams that he was welcome to visit his daughter on Sunday afternoon. Oh Brother, -- we could have none of this preference stuff, certainly not for a mere \$25,000, so we apprised our President of this intolerable situation and he calmly called Mr. Williams and asked him if he could arrange to come another time-----and all lived happily everafter.

Seniors at Tift "TOOK" the Round Table with great pomp and ceremony and after the "Taking" sat together for the remainder of the year. It was a tradition that our President always addressed us on this occasion. Dr, Chemlee said that had his daughter lived, she would have been in our class and he addressed us as if she were present. It was not morbid but very touching and impressive.

I always resimble to with the country of the state of the gram or call, and after Uncle Doc's death, 1948 (Uncle Doc always sent a Santa check of \$25 or more) he picked up the tab and sent Christmas checks to us. We oved him.

Allen Keith Chamlee, born 8-10-1877, died 10-30-1948, was the 9th of 14 children born to George Washington Chamlee (1840-1923) and Malinda Robertson Chamlee (1844-1927) Actually, he was the 7th son and therefore the nickname, Doc, because all 7th sons become doctors. With tongue in cheek, he claimed to be the only genuine doctor in his family, in as much as brother, Aquilla acquired his title by "degree" and he acquired his title by birth. This was a typical example of his wit and humor, which was enjoyed by friends and family alike.

This family of thirteen children, Emory died in infancy, was reared on a large farm 3 miles from Canton, Georgia in Cherokee County, which also had a grist mill on Chamlee Creek. So impressed was Allen Keith with the setting of his childhood, home that he had an artist paint it from a photograph. It always hung over the mantel in his Sparta home. This was a happy family, there was lots of hard farm work to be done, many brothers and sisters to play with and no lack of discipline by their father. George Washington Chamlee insisted on work, regular church attendance and schooling. Despite the fact that that he had little schooling himself, he was determined to give his children as much education as he could manage. In a letter to his soldier grandson, George Tilmon Chamlee, written May 18,1919 to Fort Bliss, El Paso, Texas, he told how he managed the schooling. "We had one teacher in Canton that I paid a salary of \$75 every year for five years- kept a wagon and tram to haul the children 32 miles- bought books, clothes end fed them- it took all I ever made but I am glad I did it- I can show as nice lot of children as can be found in the world over- something I am proud of." After such training as he was given, Allen Keith furthered his education at Mercer University, Macon, Georgia.

Before moving to Sparta, Doc Chamlee was engaged in farming and mercantile businesses in Jenkinsburg, Butts County, Ga; Lovett, Ga. Laurens County; and in Warthen, Ga. Washington County in business with Mr. George Gilmore. While working in Warthen he met Berta Ivey who was visiting her sister, Mattie, a local teacher and they were later married.

Berta Ivey was the daughter of Rev. Benjamin Henry Ivey(1848-1911) and Mattie Thompson (1856-1886). She was born in Macon, Ga. Bibb County Jan. 12, 1880 and died in Ft. Valley, Ga. Dec. 30, 1958. As her father was a Baptist minister, they lived in many places. She was a year old when they moved to Gordon, Ga. where her other sisters and one brother were born. Her mother died when Mattie was 5 weeks old, Their next pastorate and home was Sandersvolle, Ga. where her father met and married Etta Daniel on Dec. 7,1887. Rev.B.H.Ivey held pastorates also at Sisters Church out from Sendersville, Ohoope out from Tennille, Sparta, Mitchell, Iong Creek out from Warrenton and hephzibah in Richmond County. Berta Ivey graduated from Sparta High School, and from Shorter College.Rome. Ga.

There were two daughters, Benita and Venia, born to this couple. Venia was given a family name which was first given by Tilmon and Kindness Light Chamlee to their 2nd daughter, Nancy Luvenia Chamlee (1833-1898) who married Miles N.Holden of Cherokee County. It was next given by George Washington and Malinda Robertson Chamlee to their 2nd daughter, Nancy Luvenia Chamlee (1867-1949) who married Rev. John Henry Johnston.

Bentta and Venia attended Bessie Tift College, Forsyth, Ga, (as did I) while their uncle, Dr. Aquilla Chamlee, was President. Both graduated, Benita becoming Uncle Quills' Secretary. While working in Forsyth, she met and married Dr. Malcolm Taylor, Pharmacist. They made their home in Ft, Valley, Ga. where he owned a drug store. Their only child, Keith Taylor, born 1939, died during her freshman year at the University of Georgia.

Venia taught mathematics in the high schools of Gainsville, Griffin , Savannah and after obtaining her Masters Degree at Columbia University, New York, became a Mathematics Consultant Conives Forestell State Department of Education. She is retired and also makes her home in Fort Valley, Georgia.

Uncle Doc was a successful business man, owning a furniture store in Sparta and

having extensive farming and cattle operations in the county. He was a deacon in the Sparta Baptist Church, taking this position very seriously. He also sang in the choir, was interested in politics(but not in running), loved his family deeply, and he and Aunt Ta made their home a welcome place for both his and her families.

The huge front porch, which framed two sides of their house, had at least a dozen large Brumby chairs, rockers, which were usually occupied and enjoyed by relatives, friends and neighbors. Aunt Ta seta table which was like that written of to describe true hospitality, of the southern type and that at its best. Family reunions on both sides were held here, summer visitors were the rule, not the exception and from four to six teachers were usually boarding unstairs. As I recall, Uncle Doc and Uncle Beck took turns celebrating their Nuguet birthdays together. My husband, George Tilmon Chamlee, came to live with them and work in the furniture store when he was discharged from the army after World War I.

The Chemlee brothers seemed to have run in packs, Tilmon P., George Washington. Robert and Kellar went to the Chatanooga Tenn. area while the younger brothers Aquille, Allen Keith and Alexender Stephens came to the Washington County area. Aquilla Chamlee pastored churches in the neighboring counties of Washington and Hancock, in fact the Island Creek WWW.G.POWNEROCON that he pastored that church from April 1894 until October 1895 when he resigned in order to go to the Theological Seminary. Allen Keith begun working in Warthen and Alexander Stephens (Beck) located in Bartow with extensive farming interests. All three found wives in this area, Uncle Quill married Mamie Louise Beck of Tennille, Uncle Doc married Berta Ivey, and Uncle Beck married Sue Warthen of Sandersville, Ge.

During the 1920's, Victoria Chamlee Keith(1863-1945) the oldest child of the George Washington Chamlee Family, came from Selma, California to visit her people, and made the Doc Chamlee home in Sparta her headquarters. Daughter Goldie came with her. Brothers from Chattanooga, relatives from Atlanta, Canton, Bertow and Eustis Florida paid visits while she was there. She never came again. Snapshots, taken while she visited, show the marked resemblance of all to each other and in particular to their mother, Malinda.

Aunt Ta and Uncle Doc were se good to George and me, and we are honored to have a grandson named for Uncle Doc. He is Alan Barrett Chamles, born April 23, 1966, son of Tilmon and Anne Barrett Chamlee of Macon, Georgia.

This is copy of a letter written to Aunt Ta by Uncle Quill. Venia and Benita gave it to George Harvey. It wasn't dated but Aunt Ta died Dec., 30,1958 so it was before then.

My dear Ports,

I am glad to hear that you are getting even fairly well.

I am not quite sursof one or two points in the family history but am sure that all but one or two are correct.

William Chamles married Miss Seago in Cherokes County some five miles east of Canton.

Tilmon Chamles, son of William Chamles, married Kindness Light.

This was about 1835. George W. Chamles, son of Tilmon Chamles, was born in April 1840, and he married Malinda Robertson in 1862. This is our father and mother.

"Grandsir" Seago was a captain in the Army(I do not know if it was 1812 or 1776). He must have been my father's great grandfather.

The land lot on which Anderson S.C. is located was first deeded to a soldier named Chamles. An Anderson lawyer told me that he had looked at the record. That was either wonge open properson westers or a prother to one from which we descended. John (jack) Robertson was born in Hall dounty, Ga and married Elizabeth (Liza or Lou) Lynch in the early 1830's. They were the parents of Malinda Robertson, my Mother, I have so little of the Ro Robertson family tree, T.H. Robertson of Gainsville is a cousin of mother. Venia knows him, I think. He may have family history that you would like to keep

My grandmother Robertson had a brother named Charlie; she talked about an Uncle Charlie Lynch. Was this the famous family of Virginia for whom Lynchburg was named? Might be.

Sorry I cannot do better than this.

Sorry not to have a newered your letter promptly. I was ill for several weeks in October and on an antibiotic, so did not go to Canton until Nov. 6. Jerry went with me to check on the Ponder cemetery.

We find the Ponder cemetery next to the Buffington school. no church nearby. There are graves with very old rock headstones and no markings at all. We drove on up the road about three miles to the Harmony Hardshell Baptist Church Were there is also a graveyard and did some searching. There are Bates and Henderson markers as far back as 1853. (In Ponders about the oldest legible marker was 1913 date of death). There was a funeral in progress at the Church but a lady who was out in the cemetery turned out to be someone I went to school with (Mrs. Edwin Bell, nee Katie She said Wildw. Chargian see Escoron the Birmingham community was buried in the Green Gemetery, back toward Canton about four We also found this one, but none of the markers were legible. The Harmony Church was originally on this location. whese are a long way from where Grandfather George Chamlee lived. Jerry said he would ask John Keith, a neighbor, of the original Keithsburg family)if he could shed any light on this.

In the meantime, can you write me where to go to get a listing of the people buried in these old ples. I will be happy to do it in I just don't know where to start. I had resolved to ask the undertaker where the Ponder cemetery was, but Jerry knew.

Dady George has joined the seach for CHAMLEES and has come up with this. It is quoted.

School children of the United States are thoroughly briefed on the three great Colonial Captains, namely Capt. John Smith, Capt. Miles Standish and Capt. Christopher Jones of the Mayflower. What thry do not know is that there were not three but four of these captains. The fourth was Canadian and French, Capt. Jacques Chambly.

Like Capt. John Smith, Capt. Chambly was a professional soldier, a Colonel in the Hungarian Army against the Turks. When that war was over, Col. Chambly returned to France where he joined up with the Carignan Salieres regiment. He had to accept a reduction in rank to get with them, to Captain.

When the Iroquois threatened to destroy all the French Colonies in Canada, the French King sent over the Carignan Salieres Regiment.

If you get a map of Canada and Northern New York, you will see that the St Lawrence river runs across it in a generally East-West direction. If you look down into Northern New York you will see that Lake George, Lake Champlain and the Richlieu River form a water-way running due North like an arrow with george conto the St. Lawrence. It was this water highway which reached across fromt the New York home of the Iroquois directly into Canada and which the Iroquois traveled incessantly in their war against the French.

When the French chose a military leader for their struggle against the Froquois, oddly enough they did not choose the Colonels of the Regiment, whose name I can't find, but Capt. Chambly was placed in total command of the entire St. Lawrence.

The Iroquois had a system where they would travel up their lake George-Champlain, Richlieu water highway to the place where it man closest to Montreal, then they would disembark and go to work.

The first thipg Capt. Chambly did was build a fort right at the crossroads and named it Fort St. Louis. It has never been called this. If you look on your map today, it is Fort Chambly. That winter Capt. Chambly, with the French forces, invaded the Iroquois homeland and forced a peace that lasted over twenty years.
