Thomas Hiram King onlisted on March 4, 1862 in Carrollton, GA, as a Private in Co. "H", 41st Reg. GA, Volunteer Infantry, also known as "The Wool Hat Boys" with his father Benjamin King. He was wounded, permanently disabled and captured at Vicksburg, MS, on 4 Jul 1863, paroled there July 16, 1863. Roll for 31 December 1863, last on file, shows him absent and sick. Pension records show he contracted rhematism July 1863 and was furloughed for thirty days which extended until the close of the war. An affidavit submitted by William McMichale as a witness for Matilda contained the data that he served with Thomas and that Thomas did not come back into service after Vicksburg fell. He stayed at home because he was disabled from rheumatism and that when he had seen Thomas, he was on crutches. He never recovered. On June 15 1900, they were enumerated in Smithfield, Carroll County, Ca. Thomas died in 1904 and his wife Matilda died in 1910.

Matilda's pension application (dated March 2, 1904) stated that she lived in Barge, Carroll County, Ga. and that she had a weak heart, rheumatism, general disability and feebleness. She lived with her children who were supporting her. Her only property was household goods worth about \$30-\$40. It was signed March 2, 1904. Her witnesses were: William McMichael and her physicians W.W. and W. L. Pitts.

The Pension records show that Matilda was to get a pension of \$60 per year, from 1906 to 1910 Carroll County Cemetery records show her death as August 18, 1905. The 1900 census records list 10 of 12 children, all born in Carroll County. She has not been found on the 1910 census.

Clerissa Matilda Charity Chandler was the daughter of Ambrose and Jerusha White Chandler and the sister of William W. Chandler who died in the Civil War in Winchester, Virginia. It reads as follows: Mr. Lindsey Chandler, father of our esteemed citizen, Mr. Asa Chandler, died at his home in the 9th District of Carroll county last Tuesday night about 11 o'clock in his eighty-first year. He had been a consistent member of the Primative Baptist church for a number of years. Uncle Asa says he never saw him take a drink of whisky nor chew of tobacco or a sup of coffe in his life. Although very old he never wore a pair of specktacles in his life. He could see how to read or do any kind of work without them. He lived for 53 years at the place where he died. He was buried at Poplar Springs church Saturday about 1 o'clock. He leaves five children and a host of friends to mourn their loss, but their loss is his eternal gain.

We were glad to heear from you all and glad to hear you were all well. This leaves us as well as common. Was glad to hear you had good crops and that our crops are small at this time of the year. We are awful dry out here, haven't had any rain in 8 weeks til yesterday. We had a rite good rain but not near enough I think. We will have more soon. I thought this morning we would have more today but I believe it will miss us today but I hope it wil come tomorrow and I will tell you corn is nearly rwind. Well Johnny cousin Tom Chandler was out here 2 weeks ago. It was not Uncle Lindsey's Tom. It was Uncle Park's Tom. He said me and you and him was all of the boyus that are living now and he said tell you to write to him at Bremen, Ga. His address is T. B. Chandler, Bremen, Ga. He is a Primative Baptist Preacher and he is a good one too. He said he sure would love to see you. He is 11 years and 2 months older than I am and he is getting a little feeble as well as myself. Sometimes I can make it alright and t hen I am down and out. If nothing happens we will go to Georgia the second Sunday in August to a reunion and I wish you could be there. Wish you were here to go with us. We are both kin and there is lots we never say. Well I have wrote all I can think of. I will close for this time. Write soon and all the news as ever. Your brother, Levi Chandler
