I have a few notes for you on the Bass page:

Burwell, son of James and Betsy, was listed on the 1790 Greensville Co., Va. Census, 4 whites, 10 blacks. The name of his first wife is unknown, but he m. (2) Betsy Harper, 2/8/1810, in Hancock Co., Ga., leaving her LWT naming her grandchildren. Other brothers and sisters of Burwell Bass appear to be: Sterling Bass, Allen Bass, Esau Bass. Sterling Bass m. Elizabeth Dupree 5/23/1793 Greensville Co., Va. and bought land from John Day, 1805, Hancock Co., Ga. (Deed Bk F, p. 160).

None of those are closely related to this particular Burwell Bass.

Allen Bass m. Elizabeth Davis (with Burwell Bass as surety on the bond) 9/30/1790, Greensville Co., Va. and bought land in Hancock Co., Ga. from A. Youngblood, 180t (deed Bk F, p. 43). Greenville Co., Va. Order Bk No. 1, p. 8:

The marriage bond actually says Elizabeth HARRIS and the surety was Burgess Bass not Burwell.

Issue of Burwell: Benjamin and Nancy. Also Elizabeth, Ingram and Mary Ann.

Edmund S., son of James and Betsy Bass, was b. ca 1777 Greensville Co., Va., d. 5/1843 Hancock Co., Ga. m. Elizabeth H. Bass was still in Virginia in 1808...
Edmund S. married Elizabeth Harper Ingram (not Bass) 28 April 1803 Brunswick Co., VA.

Ingram Bass that married Martha Choice was the son of Burwell NOT Edmund S.

Edmund S. Bass' son was John Ingram Bass and he was married twice 1) Sarah Ellis 1826 and 2) Isabella Lockhart in 1848.

These have been greatly confused. The reason for the "Ingram" name is through the HARPER and INGRAM connection and not Bass.
