It appears that Andrew might be a son of J. E. McGarragh of (1830) Chester Co., S. C. Census. I didn't have enough time left to search this census, and compare the ages of the children. I would be very interested in seeing that old graveyard in Chester Co., Mt. Prospect, to see what McGarrahs are there, besides Rev. James. I feel strongly that your Andrew is a grandson of Rev. James. So, we need to learn the names of Rev. James' children.

Lancaster District is nearby Chester District, so I would say those there (Lancaster Co.) In 1820 are probably appropriate family.

SAMUEL EDWARD McFADDEN

Samuel Edward McFadden, lawyer; born at Chester, South Carolina, 7 December 1869; son of John C. and Margaret Louise (Waters) McFadden; attended Chester public schools, Bryant and Stratton Business College, Baltimore, Maryland; Furman University, where he graduated with degree of M.A., 1890; read law under J.L. Glenn, Chester, South Carolina; graduate of the University Law School, 1894; admitted to the bar, 1894; corporation and criminal lawyer; director and attorney for National Exchange Bank, Spratt Building and Loan Association, Chester Machine and Lumber Company, Lancaster and Chester Railway, Springstein Mills, Eureka Mills, Travelers Insurance Company; during World War made many speeches in behalf of Liberty Loan, Red Cross and other campaigns; married Ethel Means, Chester, South Carolina, 14 November 1900; member of Kappa Alpha fraternity. THE REVEREND JAMES McGARAGH

The Reverend James McGaragh was born at Doneghadee County, Down, Ireland, in July, 1752. He graduated from the University of Glasgow, Scotland, in 1781 and was licensed by the Scotlish Reformed Presbytery August 20, 1763. For several years he preached to the scattered Covenanter societies throughout Ulster. Upon an urgent request from the Covenanters in South Carolina, he accepted the call, was ordained at Bready, County Londonderry, Ireland, August 28, 1789, and set sail in 1790. In the spring of 1791 he settled on the north side of Beaver Dam Creek, Chester District, South Carolina: In Ireland he had married Elizabeth Clark who died soon after arriving in America. Their daughter Eleanor married Henry Lynn, nephew of the Reverend Matthew Lind. The Reverend Mr. McGaragh married second his housekeeper by whom he had four sons, James, William, Joseph, and David. He was suspended from the ministry June 24, 1795, and deposed April 5, 1801, by the Reformed Presbytery. Thereafter he taught school. He died September 6, 1816, and was buried in Paul's graveyard near Mt. Prospect, Chester County, South Carolina. His second wife died soon after and was also buried in the same place. To Nancy Monica, the youngest child of Jean Fee and William Cherry, is due the credit of preserving the Fee family history. Having a great desire that the present and future generations might know something of their ancestors, she devoted her time and talent to that effect for about a year.

She was born 3 November 1833 at Landsford in Chester County, South Carolina. She was married to Stephan Keenan of Lewis Station, Chester County on 16 February 1854. After his death in 1856, she removed with her widowed sister, Mrs. Eleanor Cherry Roddey to Bradley County, Arkansas, where she kept house and cared for her brother Robert's motherless children, Florence and Jennie Grace. After Robert's marriage to Anna Finch of Winnsboro, South Carolina, Nancy made her home with another widowed sister, Mary Cherry Jamieson until her marriage to James A. McGee of Humboldt, Tennessee, 17 May 1860. He died 10 August 1864.

Nancy not only lost two husbands but both of her children, a daughter at age four and a son who died 14 August 1889 at age 28. She then returned to Landsford to the old Cherry homestead to care for her aged brother, Gregory, until his death 9 December 1899. She spent her remaining years there.

James A McGee married first Lizzie Gillespie of Humboldt, Tennessee by whom he had one daughter, Eulalie, who became the wife of James A. Hamilton of that city.

JOHN McKEE

John McKee, a signer of the Ordinance of Secession, was born in County Down, Ireland, on 4 November 1787. He was the son of Andrew McKee and Jane (McKee) McKee. Jane was the daughter of James McKee; she and her husband were first cousins.

An Irish immigrant, John McKee left his native County Down, Ireland, sailed to Charleston, South Carolina, and settled in the Rocky Creek area of Chester County, South Carolina, in 1799. While there he learned the watchmaker's trade. In a deed dated 1808, Book N, Page 480, in Chester County Courthouse, Andrew McKee, watchmaker, sold to John McKee all of his watchmaking tools, books, desk, surveyor compasses, and chair. Later John moved to "Chester Hill" as the town site was then called.

John married Mary Alexander Hayden on 5 February 1818. She rode horseback from Hanover County, Virginia to Chester. They were the parents of ten children. All died in infancy except John, Junior and Mary Ellen.

Recorded January 1819 in the Clerk of Court's office in Chester is a deed showing that John McNinch deeded to John McKee property where his home with store annex stood near the present site of The Chester Hardware Company. A large piazza ran in front of the store. At the rear was a beautifully planned and cultivated rose garden and vegetable garden. A painting of Chesterville in 1835 by Margaret Kennedy gives one a good idea how the village looked at that time. A sketch of this painting is in The Chester County Library.

In 1870 the house was destroyed by fire. It was a cold winter's night, when Mary Ellen McKee, awakened by unfamiliar sounds discovered the home and their lives in danger. The family narrowly escaped death.

As a merchant, Mr. McKee carried a general stock of goods, including plantation supplies, dry goods, furnishings for the humble cottage as well as for the hand-
