William Norment of Chatham County

The Georgia State Archives card index file lists William Norment as Tax Collector for Chatham County for 1791 and 1794 and 1795. There is an 1803 deed in Montgomery County, Georgia of William Norment, Tax Collector of Chatham County, Georgia deeding some land in Montgomery County to Asa Travis of Warren County. The deed could not be copied, but I could read it. Essentially it said that the land was sold to Asa Travis on the court house steps because of back taxes. This places William Norment in Chatham County in 1803.

The enclosed deed of William Norment in Chatham dated 25 Jun 1795, Deed Book 1P (enclosed) when William and his wife, Elizabeth, sold to Slaughter Cowling 500 acres of land for 130 pds. land which was located south of Moses Nunez in the county of Burke, St. George's Parish. It was an original survey. His wife, Elizabeth gave her permission for her husband to sell the land. Incidentially, Chatham County colonial deeds locates the land of Moses Nunez on Hutchinson's Island. Burke County was in St. George's Parish (formed 1777); St. George Parish originally included parts of Chatham so the 500 acres could be closer to Savannah than supposed.

I have a copy of the 1793 tax digest for Chatham County (earliest one found) William was not listed but I the 1798 tax digest shows that he was a resident of the White Bluff district. This was the year of his marriage so he may not have been a land owner yet.

William Norment's name is found on some Chatham County Writs 1795-1802, but this was only an index and apparently the writs themselves did not survive. I searched all of the minutes of the Inferior Court (that is where the writs were filed) for that time period and did not find anything. Writs are minor complaints and cases to be heard and the only reference would be like this. Example" Smith vs. Smith. Defendant asks for appeal."

William Chandler Norment of Columbia County was listed as one of the heirs of William Norment of Mecklenberg County, NC (1786). According to the Revolutionary War Records of Mecklenburg County, Virginia by Katherine B. Elliott, William Norment was a patriot for the continental army furnishing them 575 cwt of beef, 82 cwt of bacon, a gun taken into service and not returned. He applied for payment and received 0.13. on 9 April 1782. (about 13 ½ shillings). This has to be William Norment Sr. because his son did not have anything.

William Chandler Norment was married to Elizabeth Lamkin, a sister of George Lamkin and daughter of Jeremiah Lamkin. There was a Jeremiah Lamkin who resided in Mecklenburg County, NC and who owned land in Columbia County as early as 1792. James Lamkin amassed

a very large estate of slaves and lands on the Big Kiokee Creek of the Savannah River. (estate enclosed) William C. Norment lived nearby. After his father died in Mecklenburg Co., NC, he and some of his brothers and sisters came to Georgia. No doubt, in search of new land. William C. Norment established a small farm, raising a handful of hogs, sheep and cattle, as evidenced in his estate (1805 Columbia County, appraisement enclosed.) Nothing else was found on his estate, but his widow, Elizabeth was given some slaves from her brother, George Lamkin (to manage, deed enclosed) in 1808.

Columbia County Deed Book I, page 474. 1 June 1795, looks like 1795. William Chandler Norment of Columbia County deeds to John Lamkin* of Columbia County for \$500, 150 acres of land located on both sides of the Big Kiokee Creek being one half of 300 acres originally granted to Andrew McLaw and sold to the said Norment by the sheriff of Richmond County, Georgia and being the northeast half of said tract next and near the mouth of said creek or to its juncture with the Savannah River, that part which lies on the Hurricane Branch. The Big Kiokee runs east-west from the Savannah River through Columbia County. Many early Georgia settlers established plantations along the Savannah River (which this was near) from Augusta to Savannah. *John Lamkin was 1797 tax collector in Columbia County. In 1800 John Lamkin and his wife, Eleanor sold this land to John Benning (the whole tract was 640 acres), being 200 acres granted by the Sheriff of Richmond County, Andrew McLain, at auction to William Norment.

Columbia County Deed Book P, page 13. "Whereas by the death of my father Jeremiah Lamkin of the State of Georgia (on the decision of his property) three negro slaves which negroes I have never sold or released from myself in any wise whatever. Be it known that whom it may concern that I, Samuel Lamkin at present a resident in the Mississippi Territory do hereby constitute and appoint my sister, Elizabeth Norment of Columbia County, State of Georgia aforesaid my true and lawful attorney to take charge of those negroes or any of them that may be surviving, take them in her own possession if she pleases, manage them for my use and dispose of them in such a manner that...." 1 Oct 1808. /s/George Lamkin. Given before Jonathan Davis, J. P. of Adams County, Mississippi.

William C. Norment died before 22 Jan 1805, the date an appraisement was made of his estate in Columbia County, Georgia. The slaves named were: Hal or Hall, Lucy, Mary, Hannah, Agg and Daniel. The reason I mention this is to look and see if they were included in the estate of William Stokes Norment. He apparently had 11 sheep, hogs and had 8 head of cattle. The contents of the appraisement suggest a small plantation. The sale mentions Mrs. Elizabeth Norment. Hal or Hall, Phebe, Hanner and her children were sold.

Tabitha Norment was married to Doggett in Columbia County, Georgia in 1805 and they *removed to Mississippi*. Tabitha is of the age to be a daughter of William Chandler Norment. The 1820 Wilkinson Co., MS census (enclosed) reflects a William Norment, but I do not know the age range.

Lamkin Families of Columbia County, Georgia.

James Lamkin's estate was dated 1791 in Columbia County, Georgia. Winefret Lamkin and George Lamkin swore to his Last Will and Testament on 14 Jul 1791. James Lamkin of Richmond County, left all of his estate to his wife, Winnefret Lamkin during her natural life and after her decease the tract of 200 acres of land "whereon I now live" to be equally divided between my sons, George and Cleophas, only George is to have the first choice. Also named was his son, James Lamkin, 200 acres of land in Virginia in Mecklenburg County. All of the remaining estate after the death of his wife to be equally divided among "all my children".

This makes Elizabeth (Norment) a daughter of James Lamkin who died 1791 in Columbia County and his wife, Winefret. However, she was not mentioned in the LWT of her father.

LWT of James L. Lamkin recorded 6 Mar 1845, Columbia County. Elizabeth T. Lamkin swore to the court that it was his will on 3 Mar 1845. Named wife, Elizabeth F., the plantation as I now live known as the Jones tract, containing 1,000 acres. Children: James, Emma, Mary Elizabeth to have the Marshall tract containing 1946 ¾ acres. Son, Augustus Lamkin. Mentions estate of Caty D. Denning. Son, Robert Lamkin. After the death of Mrs. Nancy Culbreath, Rachel to be freed. Dated: 4 Jun 1844.

So here were have William Chandler Norment, an heir of William Norment of Mecklenburg County, NC who removed to Columbia County, GA where he died probably in Dec of 1804. He married Elizabeth, a daughter of Jeremiah Lamkin of Mecklenburg Co., NC. After the death of William C. Norment, his daughter, Tabitha married (6 Dec 1805) Garner Doggett in Columbia County and they removed to Mississippi.

William Stokes Norment also went to Mecklenburg County where he was married in 1812. He was only 18 years old. For some reason he has left the nest to move into Mecklenburg County where William Norment (died Minutes of the Pleas and Quarter Sessions should him there in 1830 to about 1868. These were minor complaints. He had some kind of a business; was an auctioneer. These minutes have been abstracted and are at the Cobb County main Library. Also, all of the deeds and estates of Mecklenburg Co., NC were abstracted. This is a pretty thorough job. I agree, that the 1800 Robeson County, NC Census lists William Norment, with two sons under the age of 10 years. Perfect age range to be John Heyward Norment and William Norment! So, if William left Savannah to reside in Robeson Co., NC in 1800, why did he in 1803, as Chatham Co., GA tax collector, deed some land sold at auction in Montgomery County? And why was his name listed in the Chatham Co. Writs 1799-1802? (last record not found).

So here I am putting all these records together (enclosed), thinking that William Chandler Norment and William Norment of Savannah were the same persons, except for a marriage detail in 1793 of William Norment to Betsy Moore (perfect, to be the mother of William Stokes Norment). Betsy is a nickname of "Elizabeth". See the Chatham County deed of land where Elizabeth, wife of William, agrees to the sale. Unless this was Mrs. Betsy Moore, nee Elizabeth Lamkin. William C. died 1804, a daughter marries the next year; William Stokes goes back home to Mecklenburg Co., NC to his grandparents Norment and Lamkin.

Then I discovered a monumental record! On the 1798 Chatham Tax Digest there are two persons:

William Norment John Norment

You have to be age 21 or older to be on the tax digest. This cannot be William's son, John who was not born yet. William Norment (died 1786) did not name a son, John. The whole State of Georgia for this time period has 3 Norments, viz: William Norment of Savannah, William Chandler Norment of Columbia County, and John Norment of Savannah in 1798. I searched every record in Chatham County with a Norment reference. These books are very difficult to read and many of them are unindexed, but I do not think that I missed anything.

I think that John was the father of William (William named a son, John) and that William and John Norment moved elsewhere. Elsewhere could be South Carolina. I still there are strong connections to the Mecklenburg Co., NC family, but there is nothing else to search there. It seems

and Mecklenburg Co., NC) removed to Mississippi. Logically, this is Elizabeth, widow of William Chandler Norment, and next to her, their son, William. I pointing to this to show that they were pioneering other parts.

Your William was an adventurer. He'd tried his hand at business in Savannah; his son (Wm Stokes Norment) had some sort of partnership in Mecklenburg Co., NC. The Norments and Lamkins were all seeking their fortunes. For the time being, it is probably best to delay searching out William in Alabama and Mississippi, and go forward with searching for his parents. There may be some good information in his last residence, Robeson County.

I think that John (1799 Chatham Co. Tax Digest) was probably a brother or father of William. Now that I rethink this, he was probably a brother. I am enclosing a Stokes genealogy. It appears that William Stokes, born 1735 settled in North Carolina. The old-timey method of naming the first son was to use the first name of the grandparents. Thus, "William Stokes Norment" could be the Stokes and the Norment grandparents. Following this system, Stokes Norment could be the paternal grandfather and William Stokes could be the maternal grandfather. I really think that they named him after the paternal grandfather, William Stokes Norment. Later on in the system, as more children were born to the couple, they used their brothers and sisters names. The pamphlet on Stokes mentions the high stations to which some family members were elevated in North Carolina. Your William may really be "William Stokes Norment, Sr." Thus, it seems quite logical to now search for Stokes Norment in the North Carolina counties bordering South Carolina and possibly Lunenburg County, VA where Stokes and Norment's resided earlier. Of course include all of the NC counties from your notes. Then, search the bordering South Carolina counties. The reason I suggest South Carolina is we are looking for 1810 Norments (none in NC). William may have been living, for example, in Rock Hill, which today is practically a suburb of Charlotte. William Stokes Norment was "somewhere" nearby because he was married in 1812 at the age of 18. So that possibility has to be explored. Finally, trace John Stokes, father of William Stokes, progenitor of the North Carolina Stokes. He would have been born ca 1700 and this is the generation we are seeking. That could be the winning link. From what I have seen of the Norments, they were adventurers and I would suspect that William left his father's home early in life. So finding Stokes Norment will be a quest. I searched all the NC wills to 1800 and did not locate anything.

I have completed my work in the Georgia records and enclose copies of the original records discovered. Thank you for the job. Please review everything as you may have other details among your records which match.

Book 10, page 617. Jul 1855 Session. W. S. Norment, auctioneer, sold goods \$652.80. Tax \$1.41.

EARLY NC NORMENT references I've found, all of whom were presumably born before 1765 or so, maybe much earlier:

Based on above facts, it seems William Norment left Savannah around 1800. He shows up in 1800 Robeson County NC (Lumberton area). Later contemporaneous accounts of his sons establish he came to Robeson Co from Savannah and at least his son William Stokes Norment was born in Savannah about 1792; censuses for William Stokes Norment confirm his birth in Savannah. This son William Stokes married Margaret Dowd of NC and was fruitful and multiplied, leaving lots of offspring in the Robeson County area and some in Mecklenburg Co. NC (the Charlotte area). I believe William of Savannah also had a son named John Haywood Norment in Savannah in 1799 (John Haywood became a minister in NC and ultimately settled in Madison Co. AL) There are loads of records available for the Norments in NC after 1800 and I can probably piece together who had which children.

There are a couple of references I've seen, but I haven't figured out how to access them. Maybe you know.:

2. Columbia Co. GA wills (reference on rootsweb) lists 4 Sep 1810 will of william Norment, refers to wife Elizabeth. Wm. Norment is bondsman. This may be the father of a Tabitha Norment who married Garner Doggett in Columbia GA in 1805. A William C. Norment witnessed a deed there in 1809. I don't know any more about the Columbia GA family or how it might fit into the puzzle.

3. There's a reference to a Wm. Normant will in Mecklenburg 1786.call.

- 4. Journal of NC Genealogy X (Fall 1964) has article by Johnson "Some VA Carolina Connections 1726–1800." Sounds promising, but I can't find how to get this journal.
- 5. In the NC archives, there is a will listed for a Samuel Norment of Virginia in 1810. This makes me suspect that Samuel must have had some assets or heirs in NC to justify why his will would have been filed there. I have not yet figured out how or if I can get a copy of this will.
- 6. The NC archives also lists a will for Thomas Norment filed in Duplin

Co 1799, apparently in Willbook A/362. Again, I have no copy.

Right on. I am sending you a packet of copies made from original documents at the Georgia State Archives. I hope you don't mind if I charge for copies as they get .30 per page nowadays. I want you to see the originals themselves and compare the information with your data. You might see something that rings bell. Hopefully, I will mail all of this on Monday.

For a long while, I thought that William Norment and William Chandler Norment were the same people. You will see why when you think about it. However, a reference found today is daunting!

The 1785 Chatham County Tax Digest lists William Norment and John Norment. This is the first and only reference to John in Georgia! You had to be 21 to be on the tax digest, so this cannot be his son. What this means to me is that it is very, very likely that John was the father of your William. The early Georgia records have been exhausted. From what I saw in Mecklenburg Co., NC, William Stokes Norment was in some sort of partnership around 1830, and later, an auctioneer (Minutes of the Quarter Pleas and Sessions). His father, William, apparently had a partnership of some sort in Savannah (I could not find anything further on this). I think that Robeson County and the adjoining NC and SC counties are the place to look next. You might already have something in your files on John Norment. I did not see him on the 1790-1870 Mecklenburg Co., NC Census. I suspect that he can be found in SC, probably Chester District, and that this is why William Stokes Norment married in Mecklenburg County. In today's world, it is a hop, skip and jump from Charlotte into SC.

You will be able to study every document and draw your own conclusions.

Dear Ms. Austin,

Thank you for returning my call and for your willingness to assist with my attempts to connect the 18th century Norments who appear in NC and GA to their VA roots. At least I believe they must connect to the VA Norments, as the name isn't common and the dates of appearance coincide with the 3rd or maybe 4th generation of Norments in VA.

My main goal is to find the parents and/or origin of the early Norments who show up in NC and GA. Any of the early NC guys could be the father or brother of my William Norment of Savannah. I have relied thus far on censuses, records and abstracts available on the internet and have not visited the counties or archives in NC or GA so I may only have a reference to deeds and wills. You may have better sources (and obviously a LOT more knowledge).

One of my particular areas of ignorance is migration patterns. It's not hard to believe that early settlers in the Richmond VA area might have moved south and east and come across the NC border to newly developing frontiers along the coast. What I don't know is how VA settlers or NC coastal settlers might have come farther south to the Savannah area—that is, whether they took an overland route or whether they may have come by ship. I also don't know why they might have done so except because of land grants or land lotteries.

Here's a brief Norment background that might suggest where these NC/GA folks originated: Josue Norment (abt 1640-1705) immigrated abt 1689 from Scotland and settled in what is now King William County VA. The next 3 generations of Norments lived in the area of King William, Caroline and

Mecklenburg/Lunenburg Co. VA. I have attached a basic descendancy chart of the first 3 generations. It's certainly possible a few children have been missed and could be the ones that show up in NC and GA, but the only "unaccounted for" possibilities that I know about are:

William Norment b abt 1720 in King William VA (son of Samuel II); William Norment b abt 1737 (son of Joseph jr) William Chandler Norment b abt 1762 in King William or maybe Lunenburg Co VA (son of William Norment, grandson of Thomas and g-grandson of Samuel I); Thomas Norment Jr b abt 1739 in Caroline and married a Susannah (son of Thomas and grandson of Samuel I).

Yes, I see where you're going with this research and it makes sense to me to first examine the GA sightings to see what deeds and wills might add. Actually, for the 1790s, there's quite a lot I've already seen, but haven't put it together in a cohesive, way yet.

And yes, I'd like to engage you to dismantle my brick wall if the records permit. I do have to be somewhat mindful of the price I can afford (although I know firsthand how time consuming this process can be), so will \$450 cover tracking down records relating to the early GA people and possibly finding the links with VA or NC? Then might it be possible for me to do the tracking down of NC records? Also, will you provide me with copies and/or references to the sources and citations you find that are relevant? I'm trying to be disciplined enough to collect evidence. I avoid like the plaque the "instant trees" one can find on the internet with no documentation...especially the ones that show John Doe being born 75 years after his purported father's death.

Just in case it might expedite your work or give you some new leads, here are a few other things I found:

Yes, William Chandler Norment was born abt 1762 to William Norment and Mary Richardson of King Wm/Caroline/Lunenburg/Mecklenburg VA. I know nothing more about him. However, his sister Sarah Johannah Norment married John Puryear and they had a son John Puryear born abt 1772 who died in Stokes Co. NC in 1809. At least that suggests some movement to NC.

At the Kenan Research Library at the Atl. History Center, there were some books that at least hinted at some interesting materials:

In Early Deaths in Savannah GA 1763-1803, compiled by the Gen. Comm. of Ga. Hist. Soc (1993), there 3 references I saw-- -William Norman of Liberty Co; Rebecca Norman, widow, John Mallard 1trs admr (from Ga Gazette 5/18/1798 2:2) -William Normant of Liberty Co; James Smith Admr w/ will annexed (Columbia Museum 9/26/1797 4:4) -1791 William Norment granted ltrs admr for estate of Dr James Brown along with decedant's widow Mrs. Ann Brown

Got it! I reviewed your work plus examined some other misc. records.

It appears that Chandler Norment was the son of William Norment of Mecklenburg Co., VA. This Chandler was found in Columbia County, Georgia along with (your notes) William Norment. Looks like William purchased some Columbia County land from a county auction then turned around and sold it. William of Mecklenburg Co. VA died in 1789, so Chandler Norment could have been born in the age-range to be the father of your William. You see where I am going on this. The main thing is to establish more facts; thus eliminating some people.

I also found a reference to a William Norment who died 1797 in Liberty County, Georgia.

None of this is unusual. Residents of Savannah before 1800 were also found in Columbia and Richmond Counties (Augusta), and Liberty County. Before searching NC and VA records, I think it would be wise to research these Georgia Counties for any possible information in an effort to further explain who these people were. Deeds, estates, wills, tax records, etc.

This work will take awhile as these counties have extensive records. My fee is \$450.00. This is the first step before examining NC records.

Yes, William Norment of Savannah shows up in Robeson Co NC on the 1800 census. Plus, contemporaneous biographical sketches of his son William Stokes prove that William Stokes was born in Savannah and moved to Robeson with his father William around 1800. Another son, John Haywood -N/4/1799b 1799 in Savannah also went to Robeson. So I do feel satisfied that William of Savannah is the one who moved to Robeson NC.

I speculate that William of Savannah may have ORIGINALLY lived in NC, before he went to Savannah. He might have been born in VA or perhaps in NC. One clue for that is that there was a Stokes Norment who married Elizabeth Stokes (a cousin, perhaps, and it wouldn't have been the first in the family) in Perquimans Co NC in 1756. Perquimans is on the VA border. This Stokes and wife Elizabeth appear in land and court records in Craven Co NC, on the coast farther south, in the 1760s. It is tempting to wonder if this Stokes, probably born around 1735, could have been the father of William of Savannah. After all, William of

Savannah did name his own son William Stokes. I would add, however, that this family often repeated names...for instance, two brothers might each name their own sons the name of the brother's father.

As far as I know, William Stokes Norment stayed in NC. He moved from Robeson to Mecklenburg Co NC (Charlotte). Some Norments did go on to TN, AL, LA and MS, but I don't know about a Wm Stokes who did.

I know of a William Chandler Norment. He was born about 1762 in VA to William Norment and Mary Chandler Richardson. He was probably born in Caroline Co. and moved as a child to Lunenburg/Mecklenburg Co VA. I do not know what became of him, so it's certainly possible he went south.

Lots of people from Lunenburg/Mecklenburg did go to one of the Carolinas around the time of the Rev. War. This William Chandler had a couple of sisters who married Puryears, some of whom did go to NC.

***Here's something I just ran across today. Could be nothing, but could be the magic key. There's a biographical blurb in the book, A History of Savannah and South Georgia, by William Harden, published 1913. The Kenan Research Center only has a reprint, which omits Vol II. But according to the index, William S. Norment appears on page 641, which is in Vol. II. Do you have this book? If not, I may try to call the GA History Society in Savannah and see if some kind librarian would either copy the page or read it and tell me if it is helpful info. On that same page is also a reference to Newton J. Norman (could be unrelated).

Norment

William C. Norment probably died Dec of 1804 in Columbia County because an inventory of his estate was filed Jan of 1805 in Columbia County. His widow, Elizabeth, was given slaves by her brother, George Lamkin 1808 in Columbia County, so was still a resident then. I can get a copy of the 1810 bond if you want it. All that means is that the estate was still unsettled. I search distributions, returns, etc. and did not find anything further on it. Therefore, the witness listed below could not be William C. Norment in 1809.
