Know all men by these presents that I, JOHN MC DONALD, SR., Lieutenant, and CALEB RUSSELL, of Columbia County, State of Georgia, for divers good causes and considerations have made, authorized, nominated and appointed RICHARD BULLOCK our true and lawfull attorney, for us, and in our names, for our own proper use and benefit, to ask for, demand and receive of and from the Honorable Assembly or Land Office of the State of Virginia, or any other person or persons, for the Bounty of Land due us for a tour of duty by us done and performed in the said State of Virginia, in the service of our Country. The said McDonald in the year 1758, under the command of GEORGE MUNROE, in the 67th Regiment commanded by ARCHIBALD MONTGOMERY; and the said CALEB RUSSELL in the year 1755, in Captain ARMSTRONG'S Company, commanded by Colonel HANTO HAMILTON.

IN WITNESS WHEREOF, we have hereunto set our hand and seal, this 10th day of April 1801.

POWER OF ATTORNEY - PHOEBE EDWARDS, appoints W. W. HALL, att'y., Know all men by these presents that I, PHOEBE EDWARDS, admx., of the estate of JOHN MARTIN, late of Capt. TATNALL'S Company, of the 43rd Regt., U. S. Infantry, have made, constituted and appointed W. W. Hall of the city of Augusta my true and lawful attorney, for me and in my name to ask for and receive from such officers or persons as may be authorized to settle and pay the same whatever may yet be due me, and owing from the United States for the service of said JOHN MARTIN, either for balance of bounty, monthly pay, or any other account, and a full receipt for the same for me and in my name to give, and ask other acts and things necessary for settlement of the accounts of said John Martin, dec'd., for me and in my name to do in every respect as fully as I could myself do were I personally present. Hereby ratifying and confirming whatever my said attorney may lawfully do by virtue of these premises.
