NOW, THIS INDENTURE, made the *third* day of  
*February* in the year of our Lord one thousand eight hundred and seventy  
*four* and in the ninety *eighth* year of the Independence of the  
United States of America, between the said WILLIAM H. SMYTH, United States Marshal,  
as aforesaid, of the one part, and the said

*William E. Parramore*  
of the other part, Witnesseth, that the said WILLIAM H. SMYTH, by virtue of his  
office as United States Marshal of the District aforesaid, for and in consideration of the sum of

*Two hundred and sixty Dollars*  
to him in hand paid by the said

*William E. Parramore*  
at and before the delivery of these presents, the receipt of which is hereby acknowledged,  
hath granted, bargained and sold, and by these presents doth grant, bargain and sell, so far  
as the office of United States Marshal authorizes him, unto the said

*William E. Parramore*  
all of ~~that~~ *three* *lots* of land situate, lying  
and being in the *22<sup>nd</sup>* of *District* county of *Stewart*

and State of Georgia, and described as follows:

*One hundred and fifty two (152)*  
*acres of Lot number one hundred and twenty*  
*six (126). One hundred and forty one (141)*  
*acres of Lot number One hundred and twenty*  
*seven (127). One hundred and one (101) acres*  
*of Lot number One hundred and fifty one.*  
*(151), in the district, county, and state aforesaid,*  
*together with all the improvements thereon, and*  
*known, as a portion of the plantation of*  
*Thomas L. Satter, deceased,*

together with all and singular the rights, members and appurtenances, unto the said  
Lots of land, being, belonging or in anywise appertaining;  
and, also, all the estate, right, title, interest, property, claim and demand of the said  
Thomas L. Satter  
in law, equity, or otherwise whatsoever, of, in, or to, the same.

To have and to hold, the said Lots of land and premises, and every  
part thereof, unto the said

William B. Parramore  
or his heirs and assigns, to the only proper use, benefit and behoof of the said

William B. Parramore his  
heirs and assigns forever, in FEE SIMPLE, in as full and ample a manner as the said

Thomas L. Satter  
or his heirs and assigns, did or might have held and enjoyed the same,  
had it not been seized and sold under the execution aforesaid.
