(Item the first) I desire that my just debts be paid by my
 Executors hereinafter named.

(Item second) I bequeath to my son John La Fayette Adair, my
 negro man Jacob, and his wife Jude, and her boy Thomas
 about two years old, and if the said negro woman should
 have more children, I wish that the increase be equally
 divided between Mary Adair and Rachel Frost, that is that
 they have one child each, and no more.

(Item third) I bequeath also to my son aforesaid, the lot of
 land I live on, number 240 in the 14th district and 3rd section,
 also 74 acres of land it being a part of lot number 244
 in the 14th district 3rd section, also I bequeath to my son
 aforesaid all of my stock, consisting of Horses, Cattle,
 hogs and sheep.

Item 4th I bequeath to my beloved wife Ada, my negro girl Malinda, about twenty five years of age, during her lifetime, and to dispose of as she may think proper.

Item 5th I bequeath to my daughter Ann Adair, a negro girl named Caroline about four years of age.

Item 6th I bequeath to my daughter Elizabeth Adair, a negro girl named Sarah, about three years of age.

Item 7th I bequeath to my son Samuel Adair Junr. Five Dollars.

Item 8th I bequeath to my son Andrew Adair Five Dollars.

Item 9th I bequeath to my daughter Charlotte Ray Five Dollars.

Item 10th I bequeath to my daughter Catharine Bigby Five Dollars.

Item Eleventh. I constitute and appoint my Brother Edward Adair, and my son John LaFayette Adair, Executors, to this my last will and Testament, this the 21st day of August 1845.

of land contains one hundred and sixty acres more or less,
