Record of the Last will & Testament of George Niefs
In the Name of God Amen

I George Niefs of Ebenezer in the province of Georgia Planter being Very weak of body, But of perfect mind and Memory and Calling, to mind and duly Considering the Uncertainty of Humane Life, make this my last will and Testament, first and principally, I Commit my Soul into the hands of my Blessed Maker trusting in his Mercies, and in Merits of my Dear Redeemer for the Remission of all my Sins, my body I Commit to the Earth to be decently Buried in a Christian burial, As to my worldly Estate wherewith it hath pleased god, to bless me in this life I give and Dispose of in the following manner and Form. To my Beloved Son George Niefs, I Give and Bequeath all my plantation or Tract of Land whereon I now dwell, and one Calf, To my beloved Daughter Elizabeth Niefs one Calf my debts I desire to be paid out of my moveable Effects. The Remainder then, of all what is left of my moveables, I Give and bequeath unto my dearly beloved wife Sibilla Niefs, and if In case my Son George Niefs Should Depart this Life without Leaving any Heirs or Issue that then my wife Sibilla Shall be the whole and Sole Heir of my Plantation or Tract of Land and all, Singular; And I do Hereby Constitute and Appoint Joseph Schubtrine of Ebenezer Executor of this my last will and Testament as Also Guardian for my Childrens Utterly Revoking and disallowing and Disannulling, all former Requests and wills by me heretofore, left or made, declaring, Ratifying and Confirming this and no Other to be my last will and Testament, In, Witness whereof I have hereunto Set my hand and Seal this Twentieth day of February One thousand Seven Hundred & Seventy-Two & Signed Sealed Published and Declared by the said Named Testator George Niefs to be his last will and Testament In the presence of us who
