for common use the aforesaid property I do
give grant and bequeath unto my three
daughters above named to have and to
hold jointly and equally

Secondly of my other property both real estate
& personalty of whatever kind or description I
wish to have the avails of a sufficient
applied to the payment of all legal debts that
exist against me or my estate the remainder
or the avails thereof to be divided equally
amongst my other daughters after having the
above named property appraised by disinterested
persons which I have left to the said
three daughters and a sufficient of the
residue put with it to make their
separate shares to that which may fall to
the other daughters who are as follows
Mary A now wife of Zechariah Clark
Nancy now wife of Amos Clark
Mary wife of Abram Thurston

106 Hannah wife of Albert Mop Sarah Ann
wife of L J Mills

And the said remainans of
my property which I give and bequeath to
my last named daughters in equal proportion
or share to be held used and enjoyed by
them and as there separation use and disposal
through their trustees during their natural lives

And I do hereby annul all former wills
and Testaments and devises by me made I
do hereby appoint Edwin J. Mills and Albert
Mop to be and act as my Executors of this
my last will and Testament & require and
empower them to legally and faithfully transact
all business touching or affecting my estate in
any manner whatever

And I do hereby appoint and
Constitute Seth Strange Jr as trustee to act
and do with the property which I have
Conveyed to my daughters which are married
and through him the said Trustee I do hereby
Convey bequeath and grant the said shares
or portions of property falling to their lot the
same to be held for their separate use
and disposal In testimony whereof I
