

In the name of God Amen I Charles Knight of the state of Georgia and county of Henry being infirm in body but in perfect sound disposing mind and memory do make and ordain this my last will and Testament in form following, that is to say, I give and recommend my soul into the hands of Almighty God that gave it and my body I recommend to the earth to the decent interment at the discretion of my executor. And touching such worldly estate which it hath pleased God to bless me with. I will and bequeath in the following manner and form.

I will and bequeath to my son Henry Knight one feather bed and two hifens of ~~ten~~ years old, and one horse I have heretofore given makes the portion which I give him of my estate.

I will and bequeath that my daughter Martha Gafeter have nothing more she having received her share consisting of one feather bed two hifens and one mare.

I will and bequeath to my son William Knight one hifer two years old he having heretofore received one cow and one feather bed and one horse making his portion.

I will and bequeath to my son Joshua Knight one feather bed and two hifens two years old and one horse best worth sixty dollars for his portion.

I will that my other three sons Peter, John and Loya be schooled by my executor out of my estate to that of common farmers education also I

I will that my daughters Anallizer Polly Caroline and Sally be schooled by my executor out of my estate to read common prints deliberately.

And farther I will that those last named children of mine (viz) Peter, John, Loya, Anallizer Polly Caroline and Sally have the same portion given them out of my estate by my executor as I have given to the before named children. To be given to them as they respectively come of age or marry.

Also I will that all my debts be paid out of my estate after which being done all the rest and residue of my estate I leave to my beloved wife Sally Knight for the purpose of maintaining her and the last named children viz Peter, John, Loya, Anallizer Polly Caroline and Sally, and also Joshua till he becomes of age. During her lifetime or widowhood. But if she should marry then an equal division to be made of what may remain of my estate between her and all my children she having a child's part.

Also I constitute and appoint make and ordain Solomon Gafeter sole executor of this my last will and Testament and as my wife is in a state of insanity I also appoint Solomon Gafeter as guardian for my wife to prevent her from squandering or wasting said estate. And I do hereby utterly disallow revoke and annul all and every other former Testaments

and wills by me in any way named wills and bequeathed ratifying
and confirming this and no other to be my last will and testament
